Department of Revenue. The Certified Florida Appraiser

Designation is reserved for the county official.

The qualifications for the Certified Cadastralist of Florida include at least two years of experience for the Florida Property Appraiser's Office or the Florida Department of Revenue. At least 150 hours of approved education and current employment with the Florida Property Appraiser's Office or the Florida Department of Revenue.
