2 MS. LEWIS: Good morning, everyone. Welcome
3 to the Certified Florida Appraiser Admissions and
4 Certifications Committee. My name is Rene Lewis.
5 I am the Director of the Property Tax Oversight
6 program and the chair for today's proceedings.
7 The committee, as a public board, is subject to
8 the Government in the Sunshine laws, and therefore
9 the committee's meetings are required to be open
10 to the public and properly noticed. This applies
11 to any gathering of two or more committee members
12 where there is discussion about a matter that
13 could come before the committee for action.
14 Ms. Rachel Goldstein, Chief Legal Counsel for the
15 Property Tax Oversight Program, is on the phone.

16 MS. LEWIS: According to Rule 12D-19.002(6)

17 Florida Administrative Code, five members of the
18 Admissions and Certifications Committee constitute
19 a quorum. Meghan, do we have a quorum?

20 MS. MILLER: Yes.

21 MS. LEWIS: Thank you. Our first order of
22 business today is the approval of the June 11,
23 2025, Certified Florida Appraiser Admissions and
24 Certifications Committee meeting minutes. Do I
25 have a motion to approve the June 11th committee

1 meeting minutes? Please state your name if you
2 make a motion.

3 MR. WILLIAMS: David Williams, motion to
4 approve.

5 MS. LEWIS: Thank you, David. I have a
6 motion by David Williams. Do I have a second?

14 Our next item of business is the presentation
15 and recommendation of applicants. The program
16 posted the list of applicants, along with the
17 completed applications, on the Department's
18 website and sent the meeting materials link to
19 each of you. Each application has a checklist at
20 the front to assist you in your review of the
21 applicants. This checklist has the certification
22 criteria required in Rule Chapter 12D-19, F.A.C.

23 Meghan, will you please list the requirements
24 of the Certified Florida Appraiser, Certified
25 Florida Evaluator, and Certified Cadastralist of

1 Florida designations, please?

2 MS. MILLER: The qualifications for the
3 Certified Florida Appraiser and Certified Florida
4 Evaluator professional designations include at
5 least two years of experience with a Florida
6 property appraiser's or tax collector's office or
7 the Florida Department of Revenue, at least 120
8 hours of approved education, and current
9 employment with a Florida county property
10 appraiser's or tax collector's office or the
11 Florida Department of Revenue. The Certified
12 Florida Appraiser designation is reserved for the
13 county official.

14 The qualifications for the Certified
15 Cadastralist of Florida include at least two years
16 of experience with a Florida property appraiser's
17 office, tax collector's office or the Florida
18 Department of Revenue, at least 150 hours of
19 approved education, and current employment with a
20 Florida property appraiser's office, tax
21 collector's office or the Florida Department of
22 Revenue.

23 MS. LEWIS: Thank you, Meghan. Now, I need
24 for each Committee Member to individually answer
25 the following question on the record. After I

1 read the question, Meghan will call the name of
2 each member. Please state your answer of yes or
3 no.

4 The question is: Are you aware of any facts,
5 situations, or reasons which you feel may
6 disqualify or otherwise make it improper for you
7 to hear and deliberate on any of the applicants
8 scheduled to be reviewed today?
