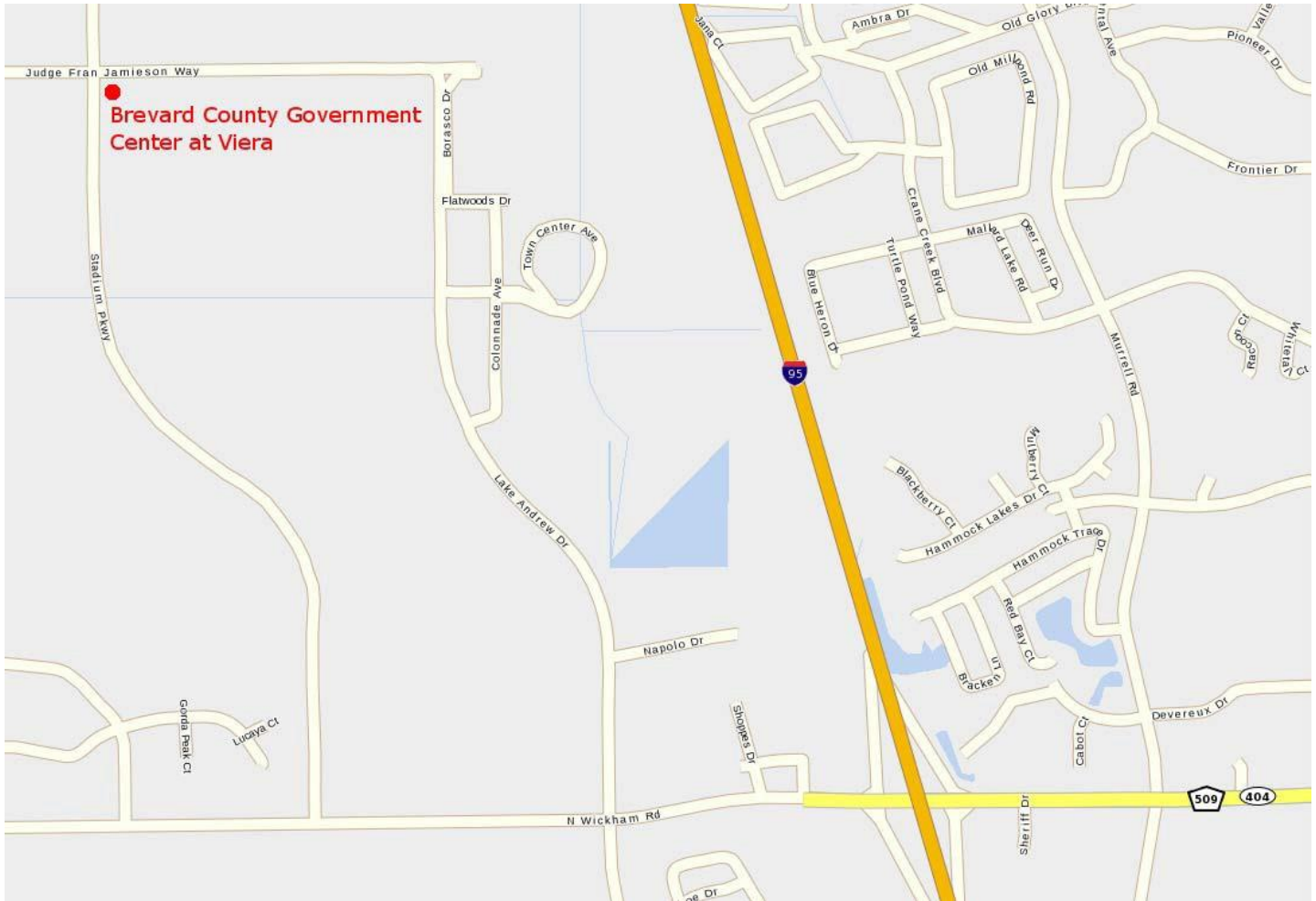

Directions:

From I-95: Take exit 191 toward Satellite Beach/Patrick A.F.B/Brevard Country 509. Turn (if you're coming southbound and getting off the interstate, you'll turn left; if you're coming northbound, you'll turn to the right) onto N. Wickham Rd. and head west. After continuing through the traffic circle, turn right onto Stadium Pkwy (landmark: at the intersection of Stadium Parkway and Wickham Road is a "Duran Golf Club" sign). Make a right onto Judge Fran Jamieson Way. The Brevard County Government Center will be on the right.

Parking:

Parking is available in the Brevard County Government Center parking lots, located behind the Center. Disabled parking is available in marked spaces.
