5. How do I know if I need to take the exam?

- ▶ If you have between three and five years of relevant experience and meet all other qualifications in section 194.035(1), Florida Statutes (F.S.), you must complete an exam to become a special magistrate.
- ▶ To use this training toward qualifying education for the Certified Florida Appraiser (CFA) or Certified Florida Evaluator (CFE) designations, successful completion of the exam is required.

5. How do I know if I need to take the exam? (continued)

- ▶ Individual counties may require completion of an exam. Contact your county's VAB clerk for more information.
- ▶ Testing is not required for other participants in the VAB training, but they may complete an exam if they prefer.
- ▶ To help promote and maintain a high level of public trust in the VAB process, the Florida Department of Revenue (Department) encourages all real property special magistrates to complete and pass this exam.

6. What is the difference between the training certificate and exam certificate?

- ▶ The training certificate is your documentation that you have taken the VAB training course indicated on the certificate.
- ▶ The exam certificate is your documentation that you have taken the VAB training course indicated on the certificate and successfully completed the associated exam.
