RE: Florida Department of Revenue Proposed Rules

Dear Ms. Jackson:

At their May 23, 2023, public meeting, the Governor and Cabinet approved the publication of the Notice of Proposed Rulemaking and subsequent adoption and certification of the Department of Revenue's proposed general tax administration rules if the substance of the proposed rules remain unchanged upon reaching the date for final adoption. The proposed rules included:

Rule 12E-1.012, F.A.C. – Consumer Reporting Agencies

Rule 12E-1.023, F.A.C. – Suspension of Driver License; Suspension of Motor Vehicle Registration

Rule 12E-1.027, F.A.C. – Written Agreements for Payment of Past-Due Support

Rule 12E-1.028, F.A.C. – Garnishment by Levy

Rule 12E-1.029, F.A.C. – Financial Institution Data Matches

Rule 12E-1.030, F.A.C. – Administrative Establishment of Child Support Obligations

Rule 12E-1.036, F.A.C. – Administrative Establishment of Paternity and Support Obligations

Rule 12E-1.039, F.A.C. - Request for Services

Rule 12E-1.040, F.A.C. – Intergovernmental Forms

Rule 12E-1.041, F.A.C. – Review for Modification of Support Order

Rule 12E-1.042, F.A.C. – Income Withholding

A Notice of Proposed Rule for these rules was published in the Florida Administrative Register (F.A.R.) on May 30, 2023 (Vol. 49, No. 104, PP. 2029-2038).

A notice of change for Rules 12E-1.029, 12E-1.030, 12E-1.036, 12E-1.040 and 12E-1.041, F.A.C., was published in the Florida Administrative Register on July 12, 2023 (Vol. 49, No. 134, PP. 2505-2507); however, the substance of the proposed rule remains unchanged.

A notice of change for Rule 12E-1.029, F.A.C., was published in the Florida Administrative Register on August 2, 2023 (Vol. 49, No. 149, PP. 2825-2826); however, the substance of the proposed rule remains unchanged.

The Department reviewed the proposed rules listed above and determined that the proposed rules likely will not have an adverse impact on small business, small counties, or small cities, and are not likely to have an increased regulatory cost in excess of \$200,000 within 1 year. No Statement of Estimated Regulatory Cost is required for the proposed rules. The rules do not require ratification by the Legislature pursuant to Section 120.541(3), F.S.

The Department requests that the Committee file its certification with the Bureau of Administrative Code on August 25, 2023.

The Department of Revenue will file the proposed rule amendments for certification with the Department of State on August 25, 2023, for an effective date of September 14, 2023. This rule is filed within 90 days after the notice, but not less than 21 days nor more than 45 days from the date of publication of the notice of change.
