SALES AND USE TAX

Sales and Use Tax collections were \$3,228.9m in January, and above the January 2019 collections by \$1.1m (0%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.

CORPORATE INCOME TAX

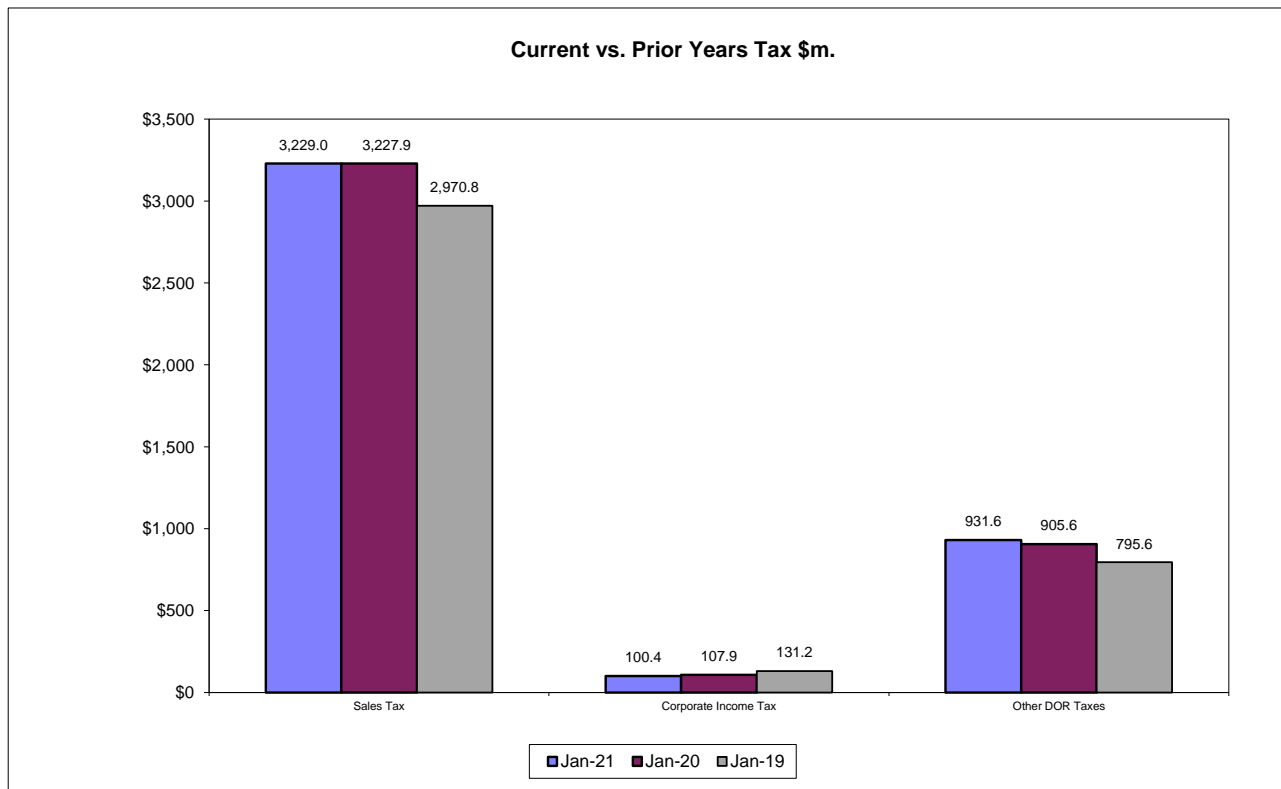
CIT collections of \$100.4m in January 2020 were under the January 2019 collections by \$7.5m (-6.9%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections of \$332m were above the January 2019 collections by \$73.7m (28.5%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

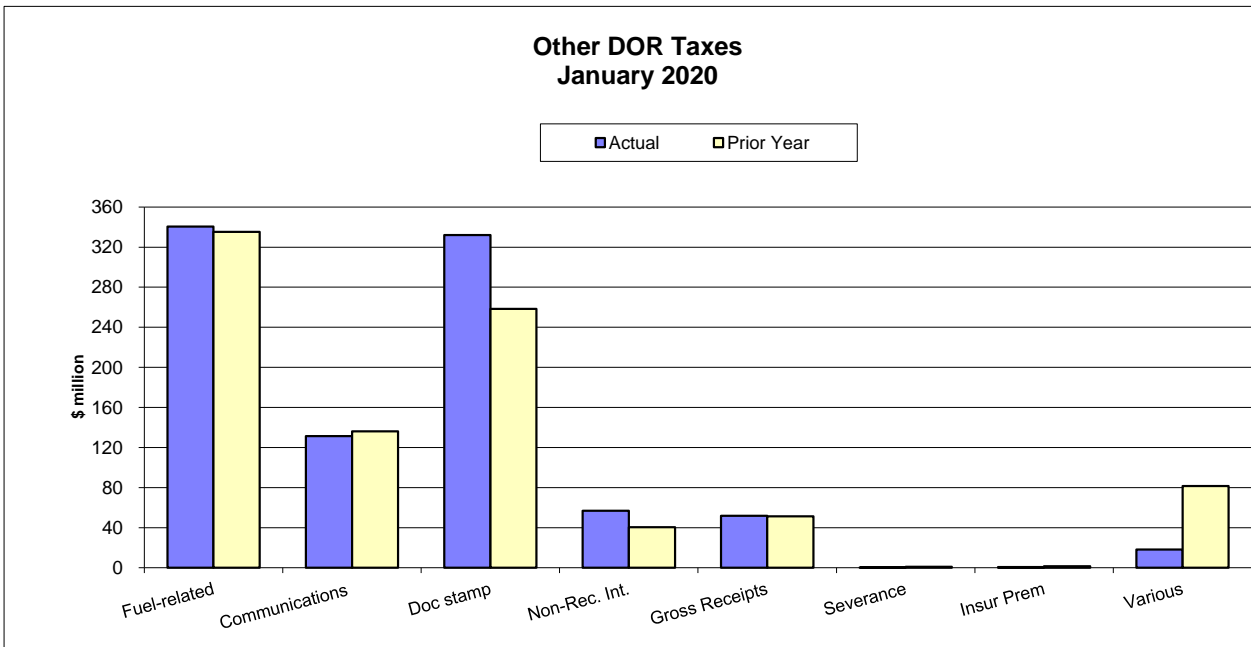
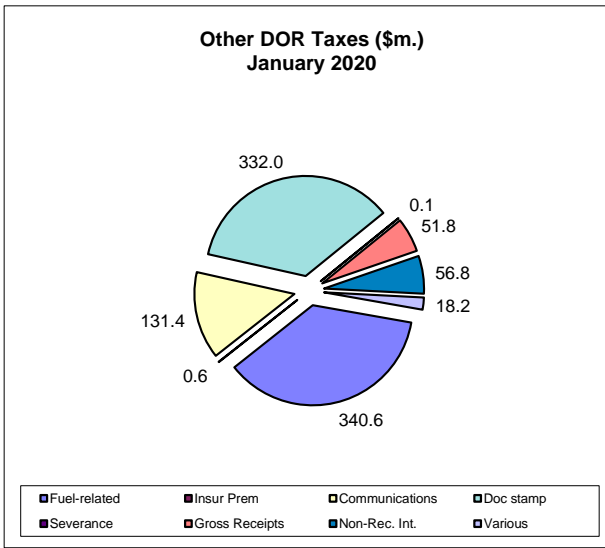
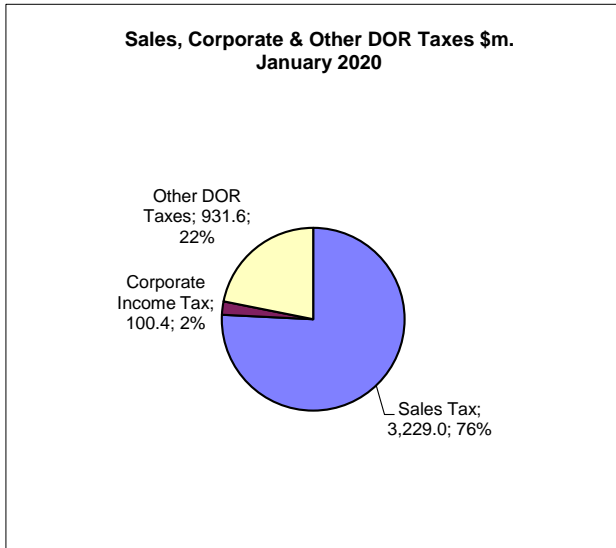
... COLLECTIONS of \$100.4m in January 2020 were under the January 2019 collections by \$7.5m (-6.9%).



OTHER DOR TAXES...

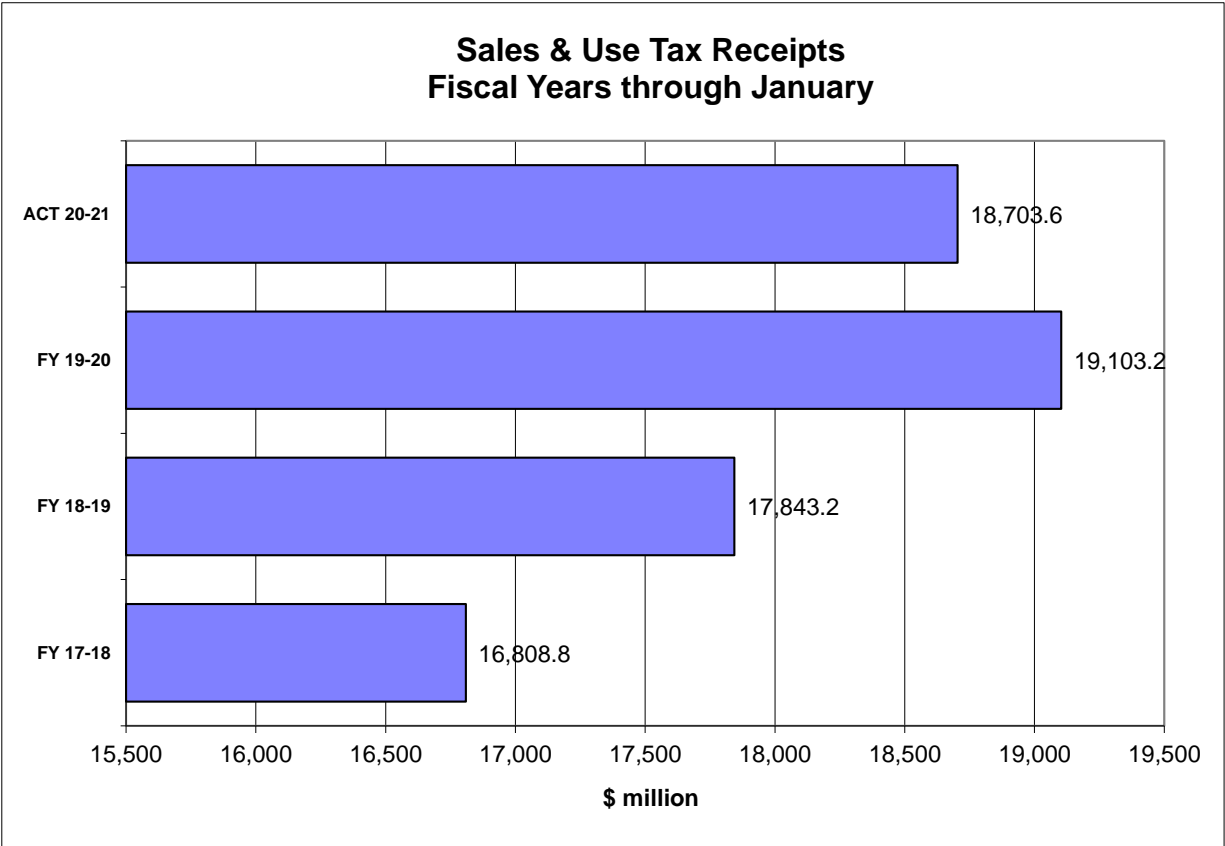
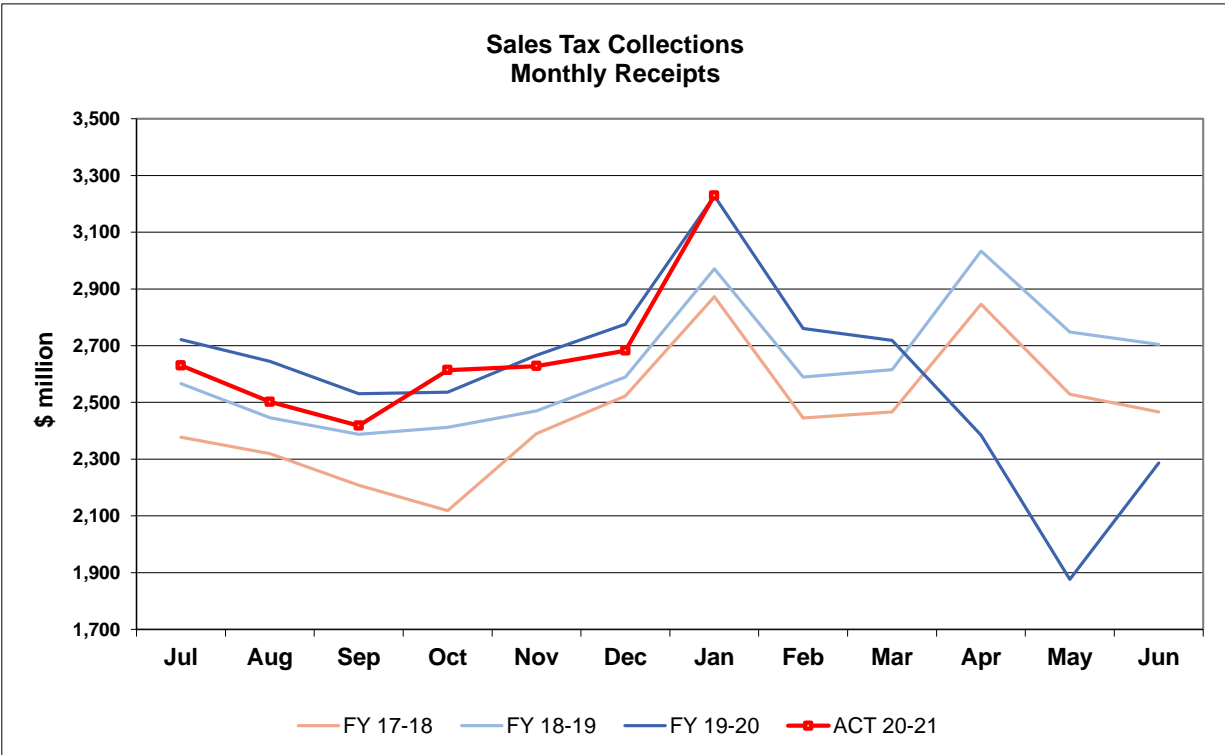
...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$931.6m to DOR tax collections in January 2020. The January 2020 collections were \$26m (2.9%) above the same month previous year's collections. The Doc Stamp Collections in January 2020 were \$332m. Compared to January 2019 collections on Doc Stamp Taxes, the January 2020 collections were \$73.7m (28.5%) above.

The January 2020 collections of the Communications Services Tax compared to January 2019 collections were \$4.8m (-3.5%) below. The collections of Insurance Premium Tax in January were 1m. Compared to January 2019 collections on Insurance Premium Taxes, the January 2020 collections were \$0.8m (-58.7%) below. The collections of Fuel-related Taxes & Fees in January were above the prior year by \$5.2m (1.6%). The non-recurring Intangible Tax collections were \$16.4m (40.5%) above the prior year.

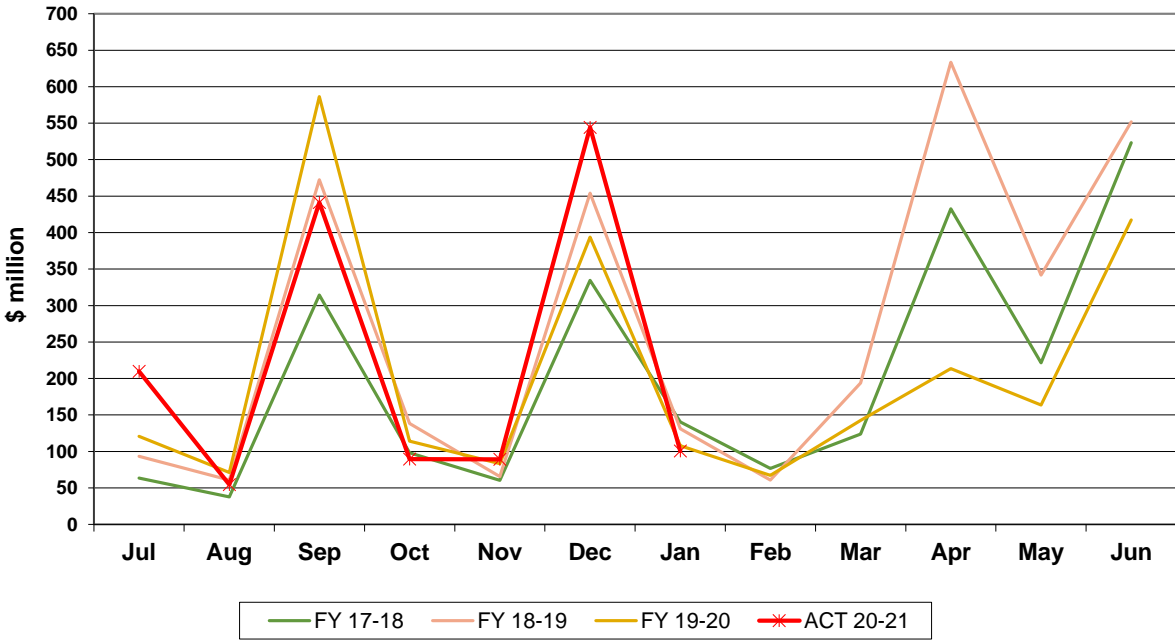


HISTORICAL COMPARISON GRAPHS

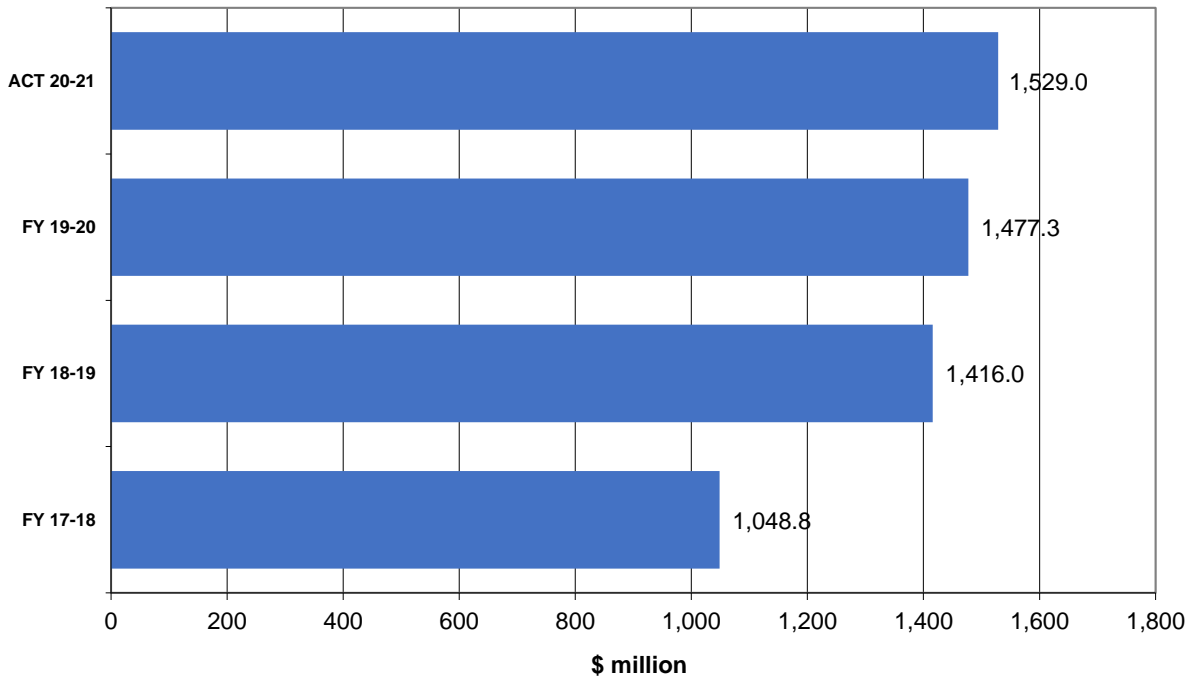

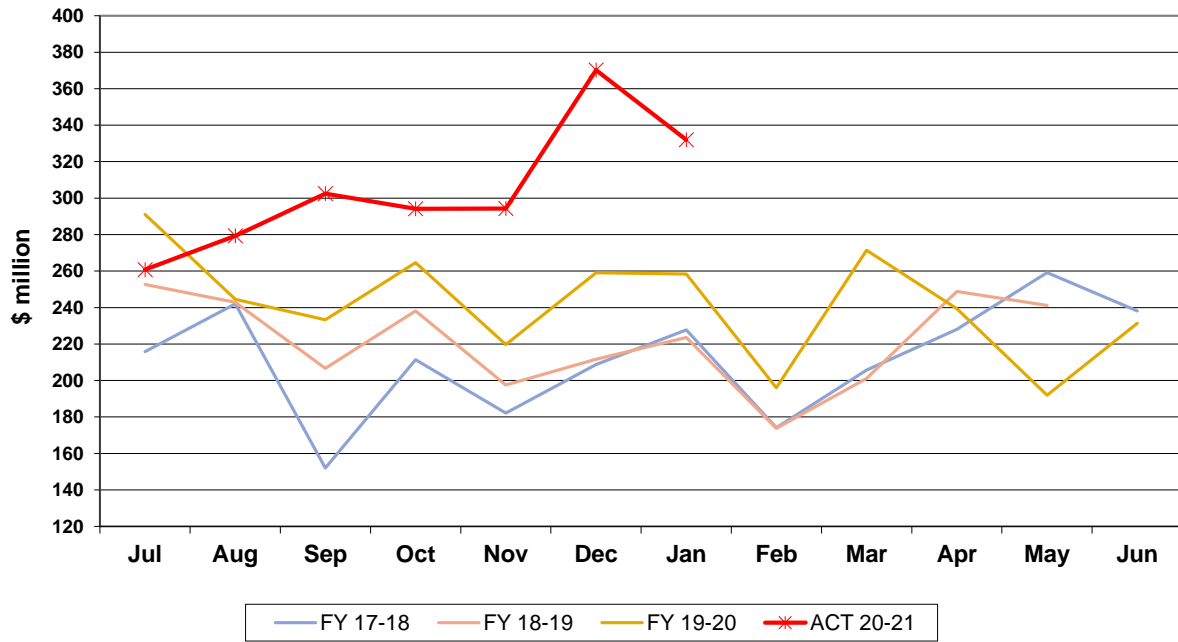
Corporate Tax Collections Monthly Receipts



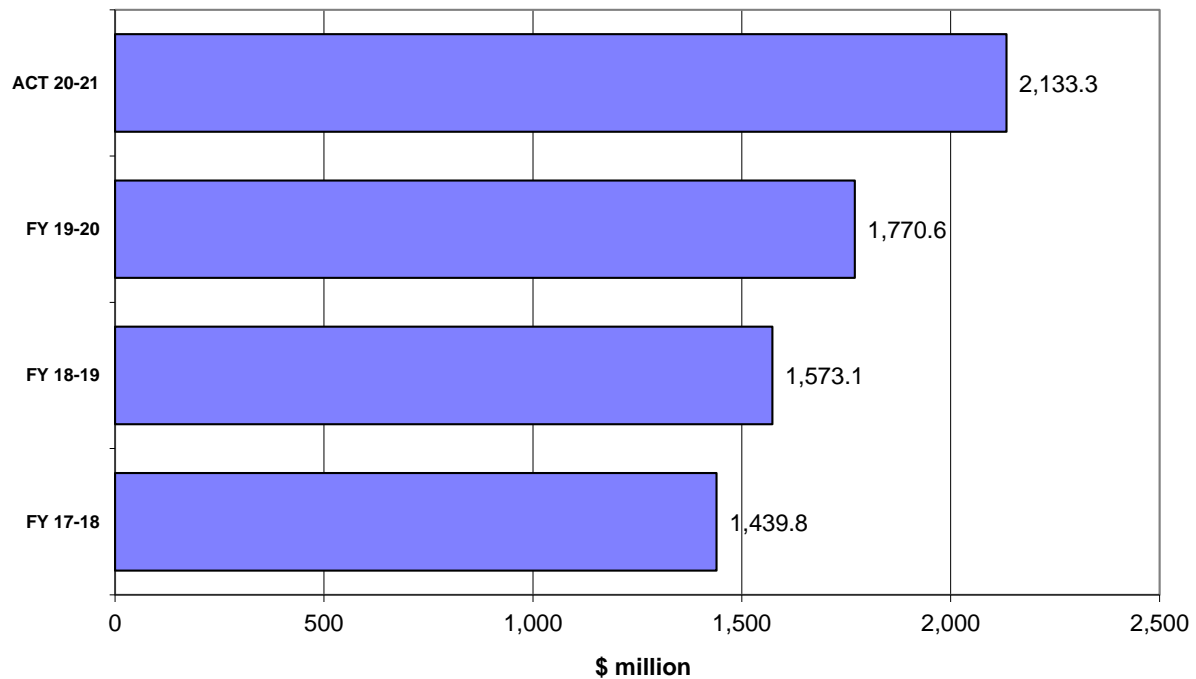
Corporate Income Tax Receipts Fiscal Years through January



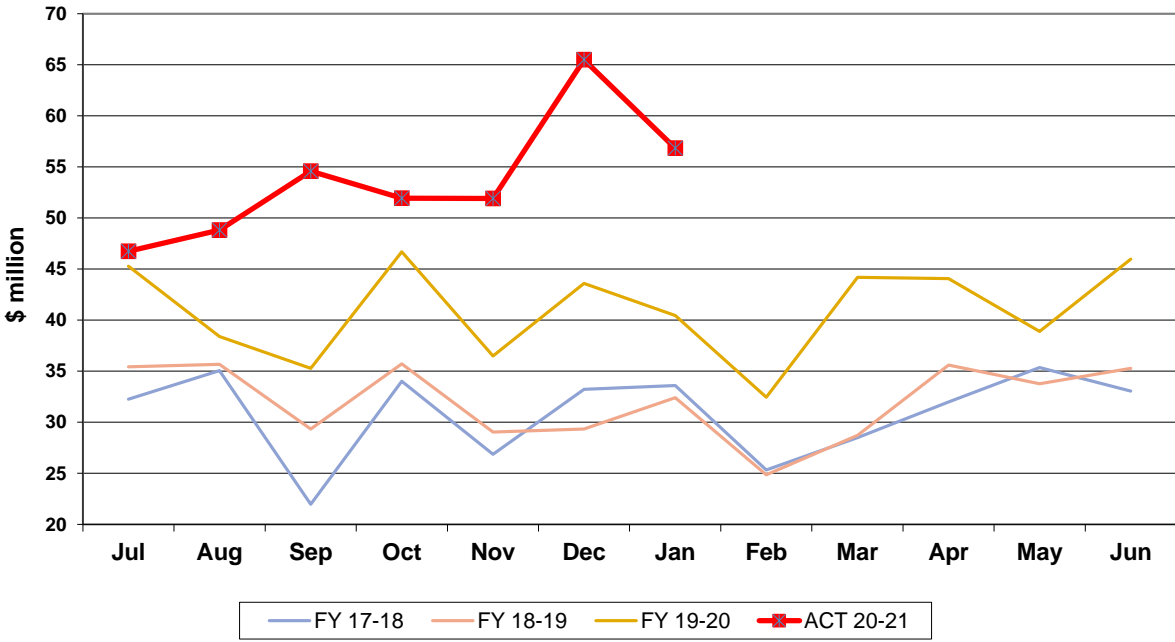
Doc Stamps Tax Collections Monthly Receipts



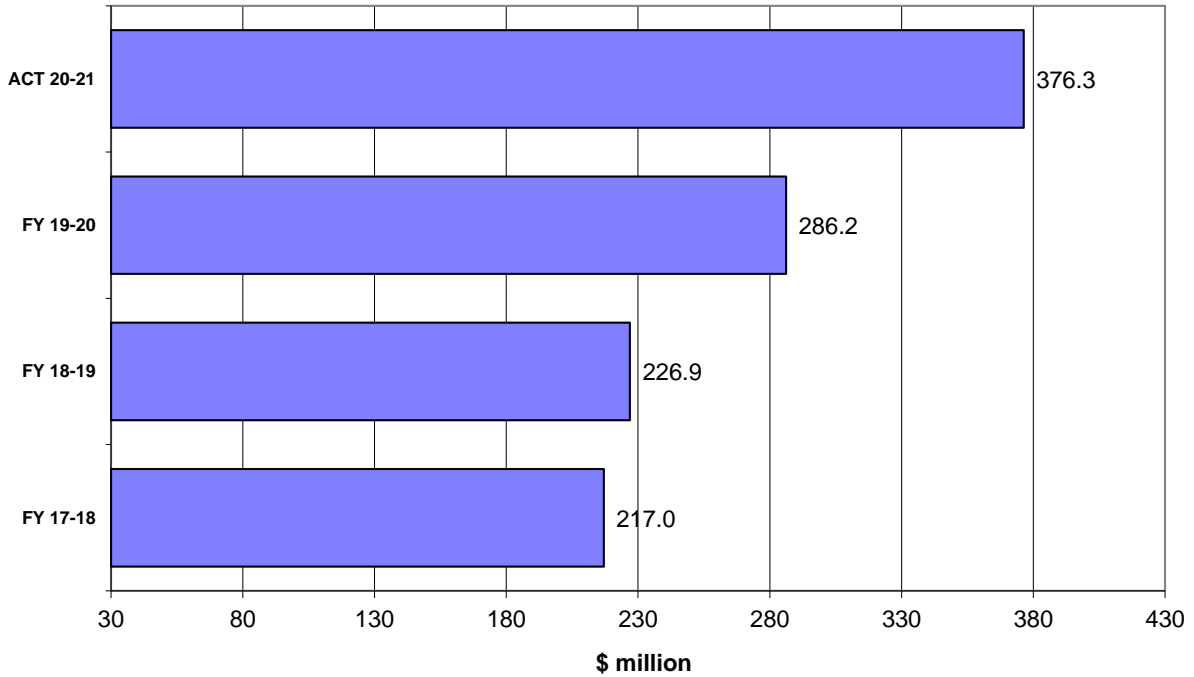
Doc Stamps Tax Receipts Fiscal Years through January



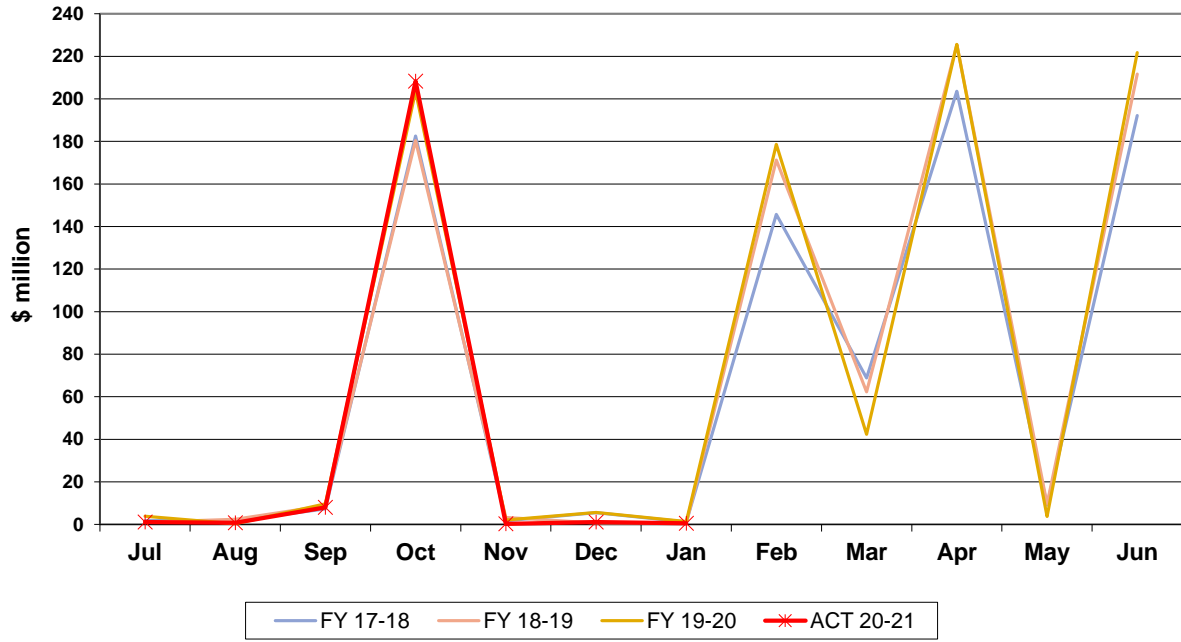
Non-Recurring Intangible Tax Collections Monthly Receipts



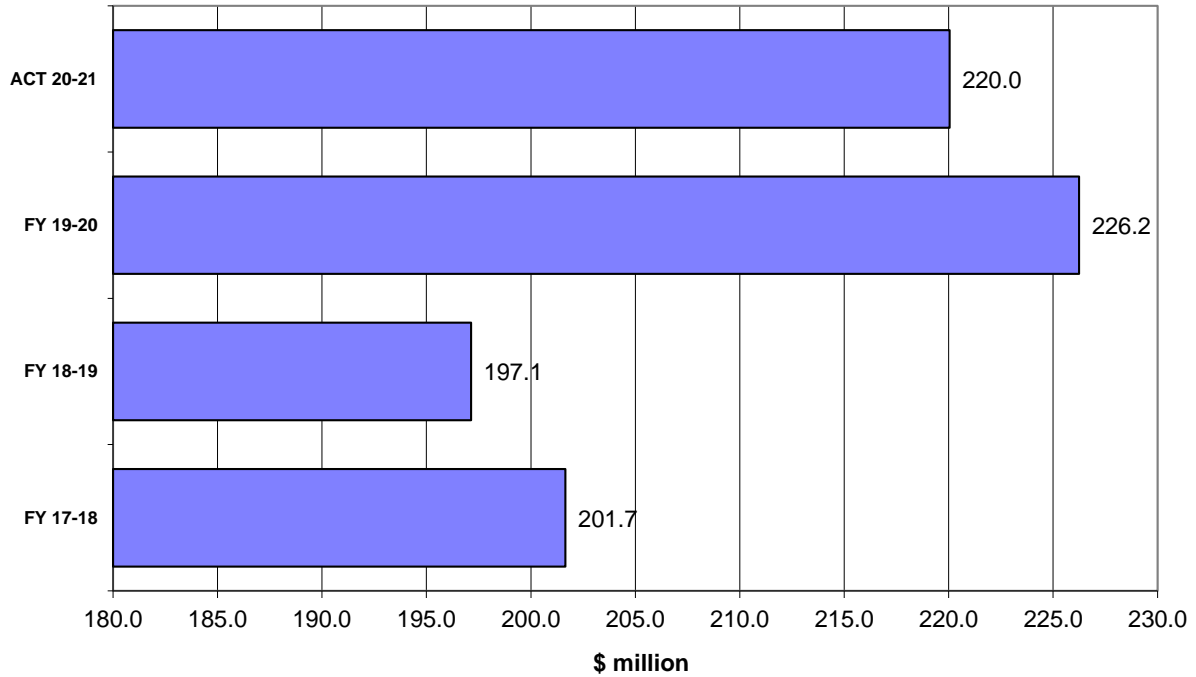
Non-Recurring Intangible Tax Receipts Fiscal Years through January



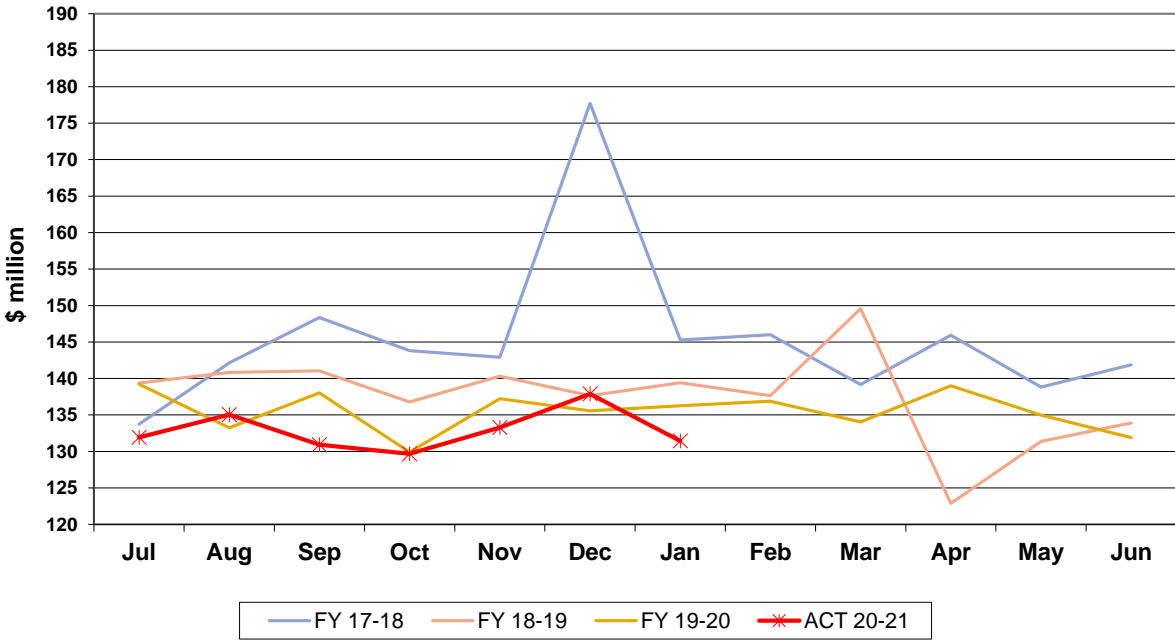
Insurance Premium Tax Collections Monthly Receipts



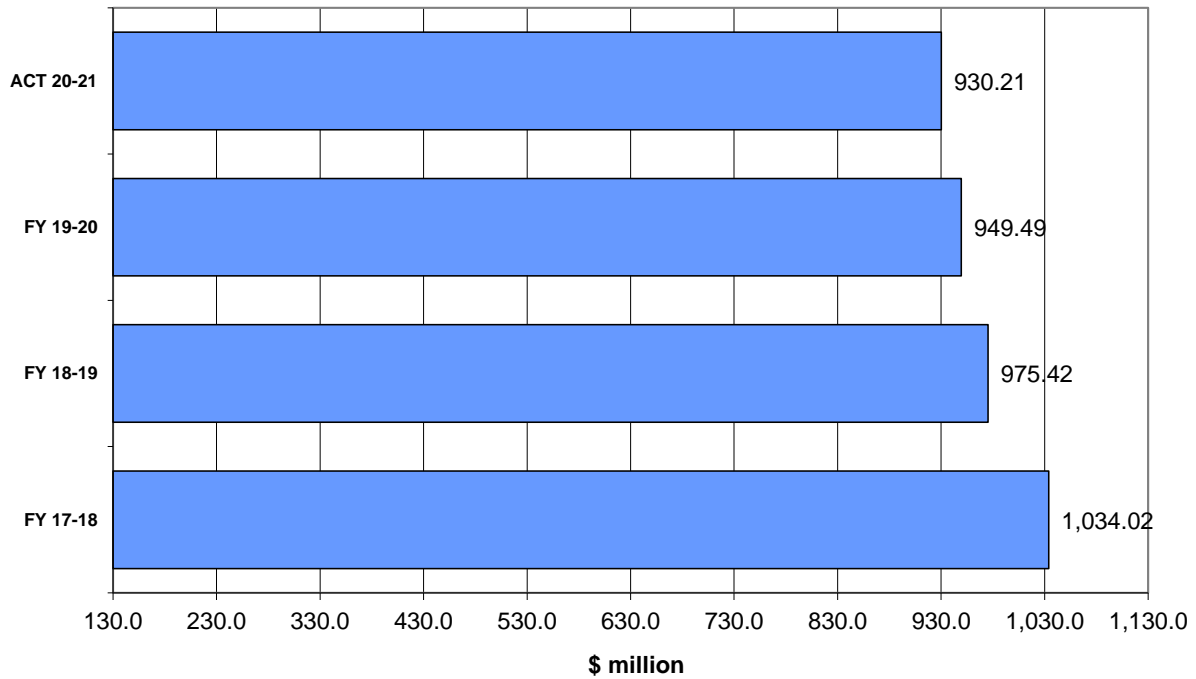
Insurance Premium Tax Receipts Fiscal Years through January



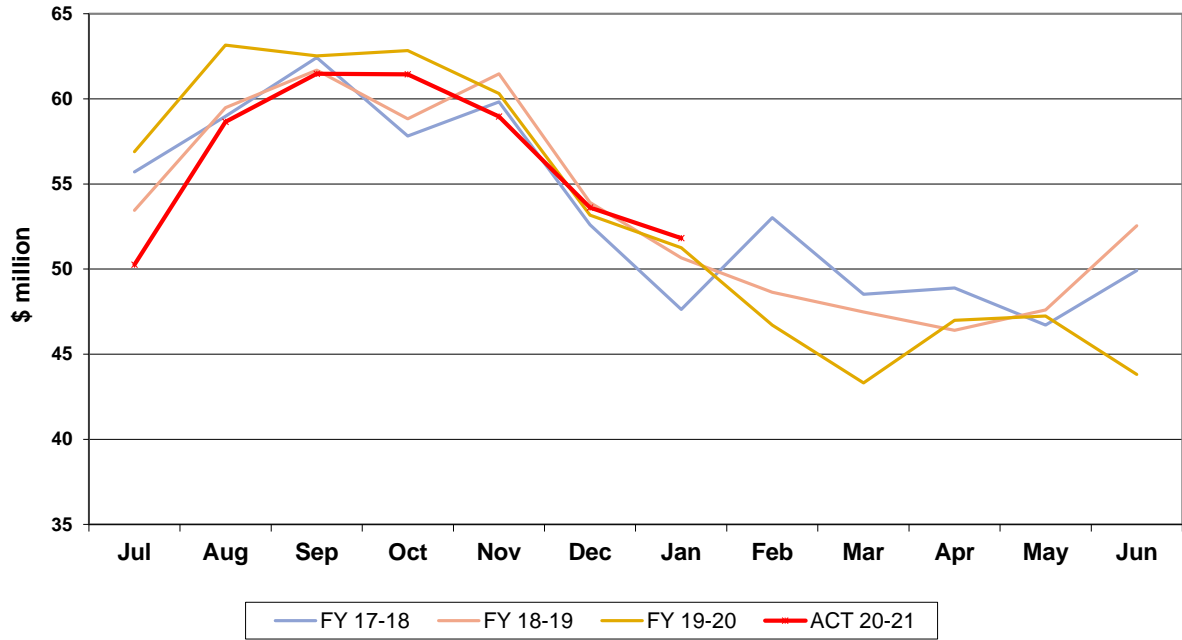
Communication Services Tax Collections Monthly Receipts



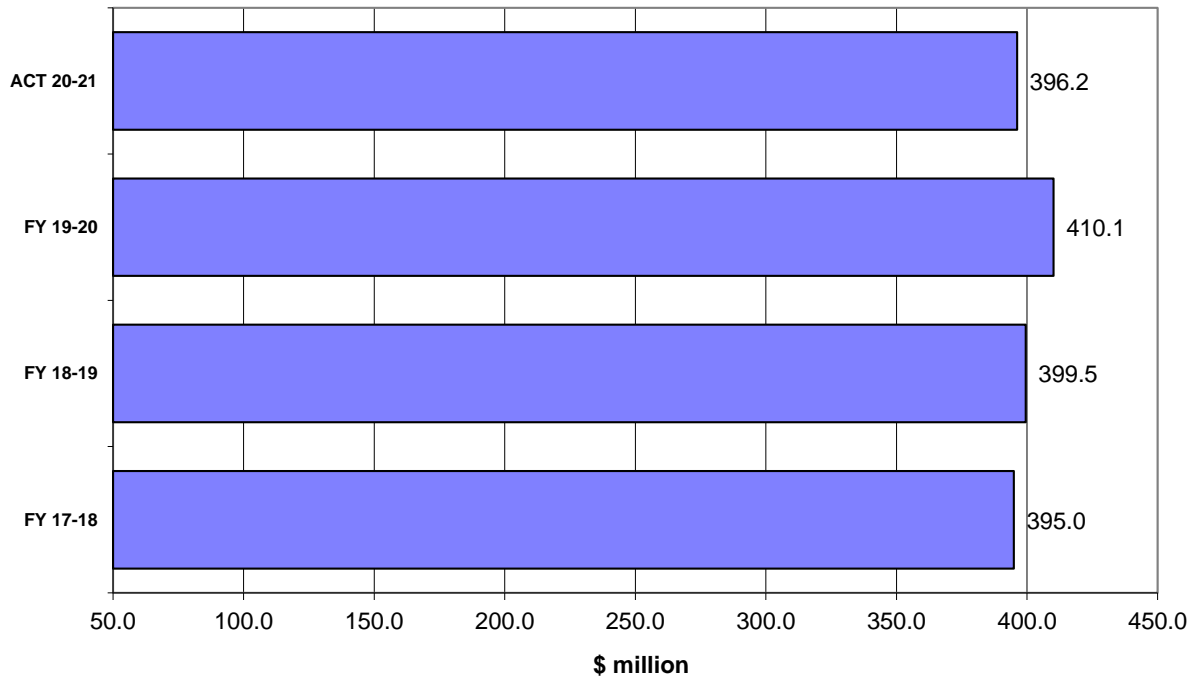

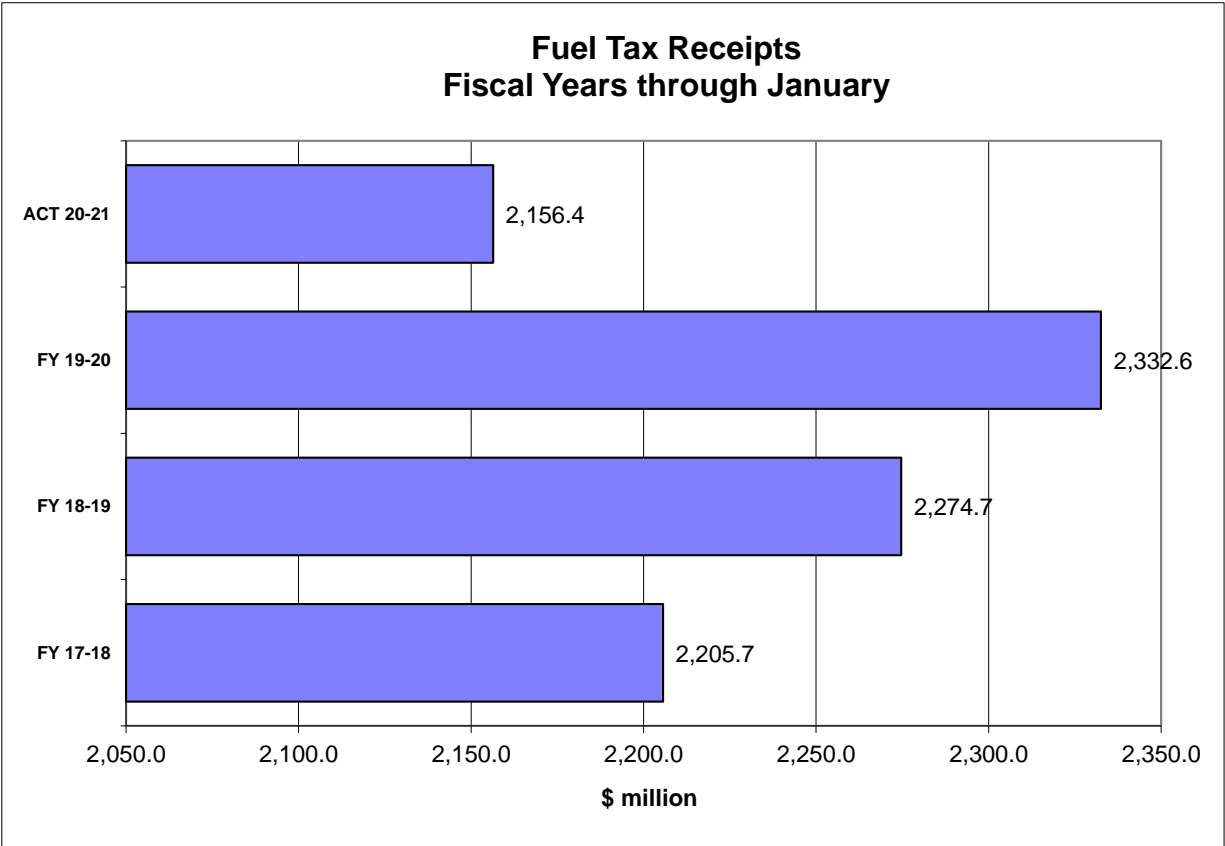
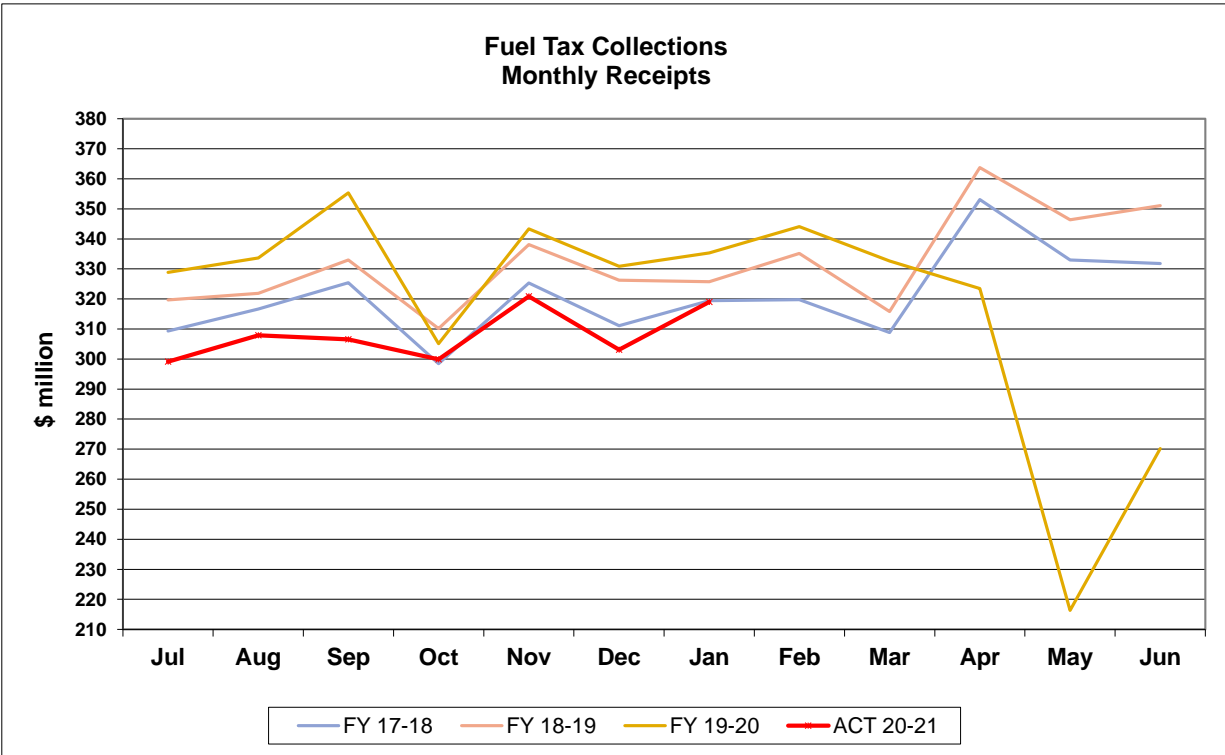

Monthly Receipts**

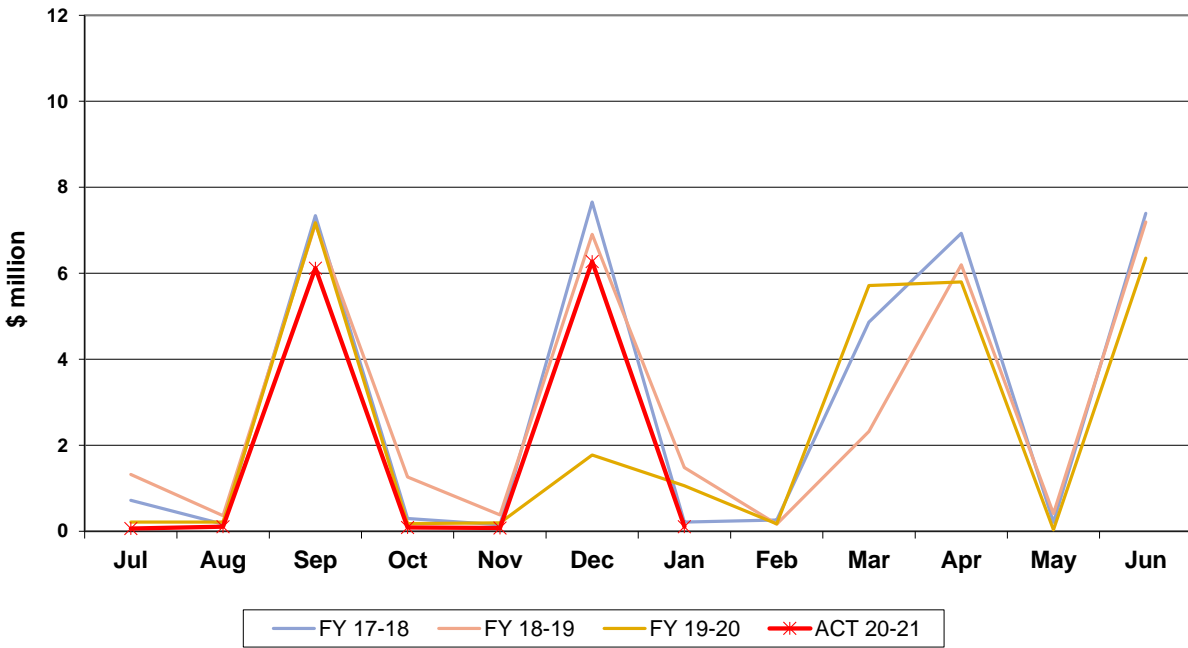
