**SALES AND USE TAX**

Sales and Use Tax collections were \$2,762.3m in March, and above the March 2020 collections by \$44m (1.6%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.

**CORPORATE INCOME TAX**

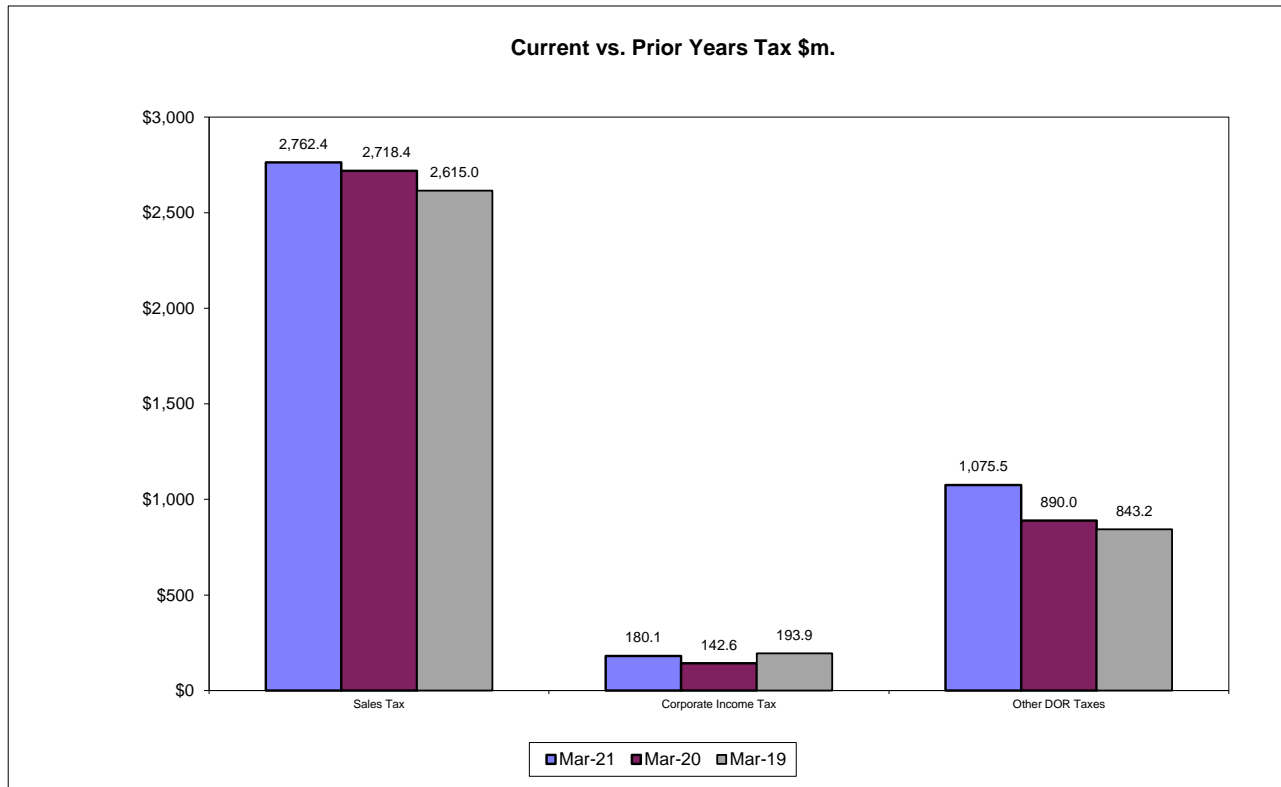
CIT collections of \$180.1m in March 2021 were over the March 2020 collections by \$37.5m (26.3%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

**DOCUMENTARY STAMP TAX**

Documentary Stamp Tax collections of \$386.7m were above the March 2020 collections by \$115.2m (42.5%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

# OTHER DOR TAXES...

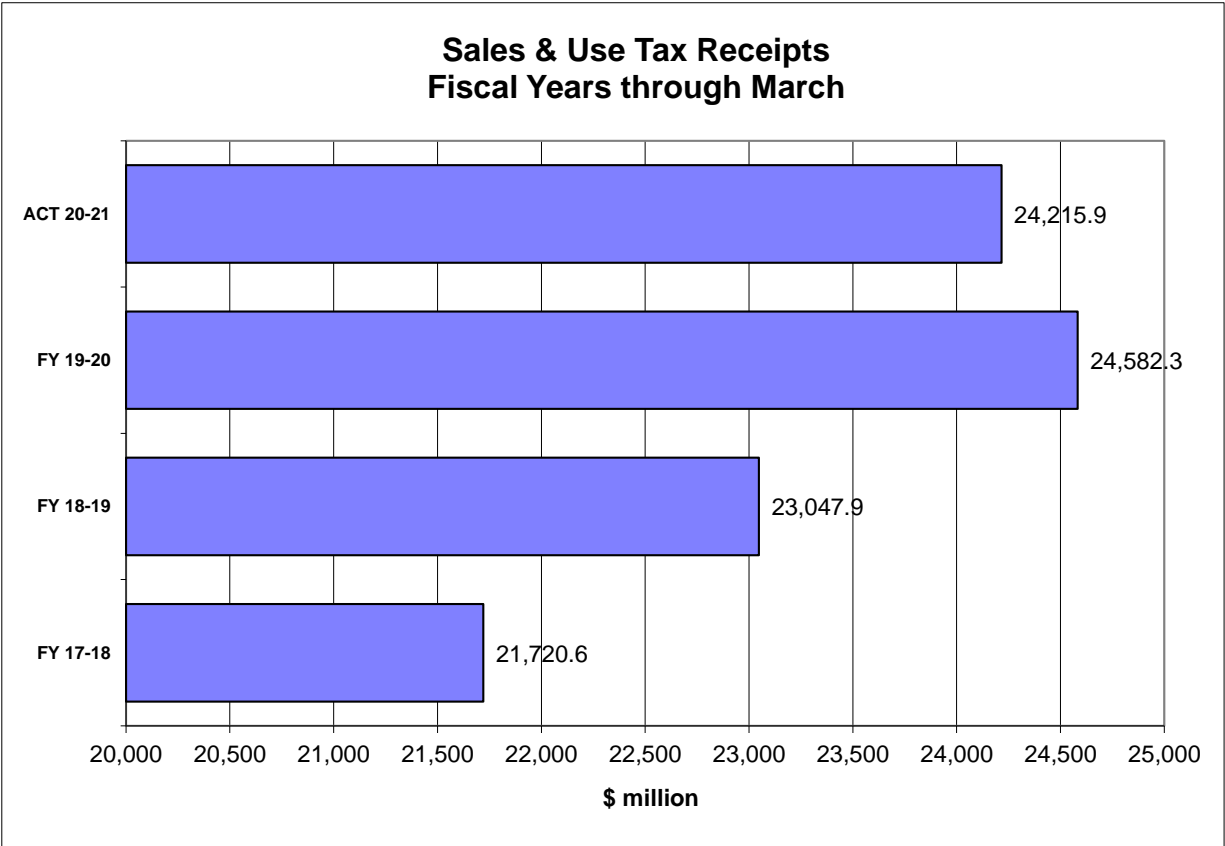
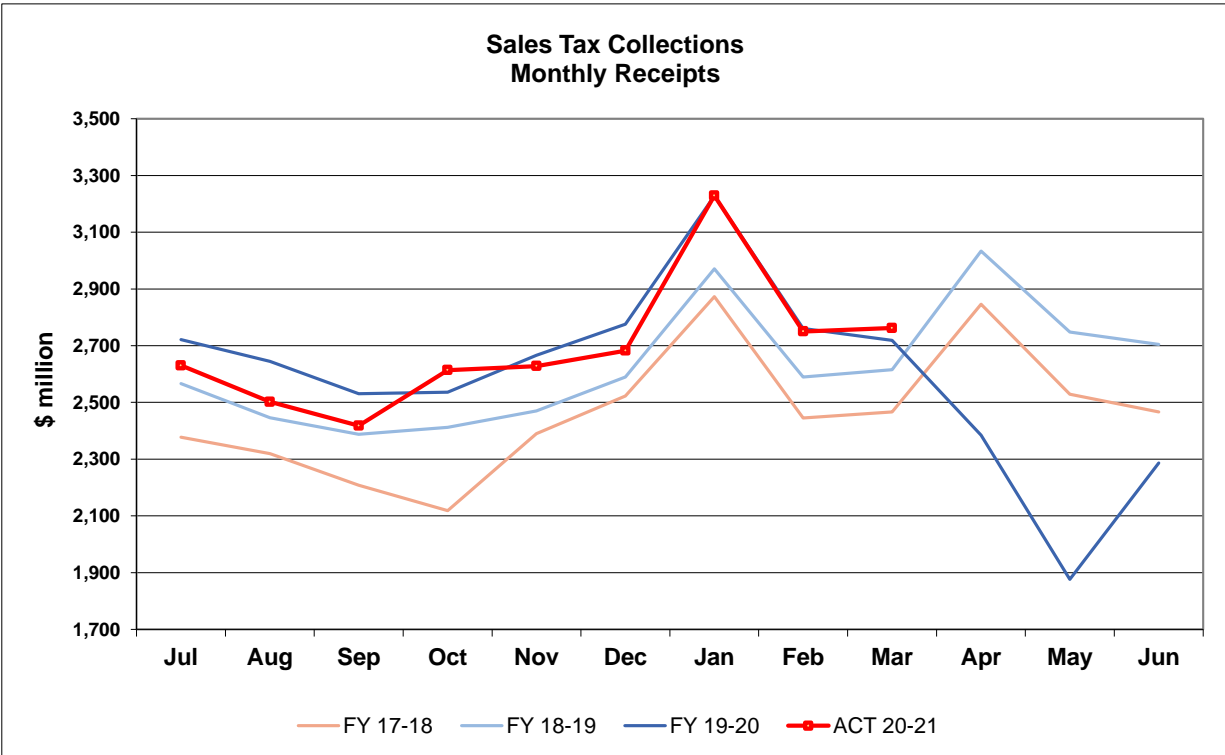
...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$1075.5m to DOR tax collections in March 2021. The March 2021 collections were \$185.5m (20.8%) above the same month previous year's collections. The Doc Stamp Collections in March 2021 were \$386.7m. Compared to March 2020 collections on Doc Stamp Taxes, the March 2021 collections were \$115.2m (42.5%) above.

The March 2021 collections of the Communications Services Tax compared to March 2020 collections were \$7.2m (-5.3%) below. The collections of Insurance Premium Tax in March were 59.6m. Compared to March 2020 collections on Insurance Premium Taxes, the March 2021 collections were \$59.9m (141.4%) above. The collections of Fuel-related Taxes & Fees in March were below the prior year by \$10.8m (-3.2%). The non-recurring Intangible Tax collections were \$22.4m (50.8%) above the prior year.

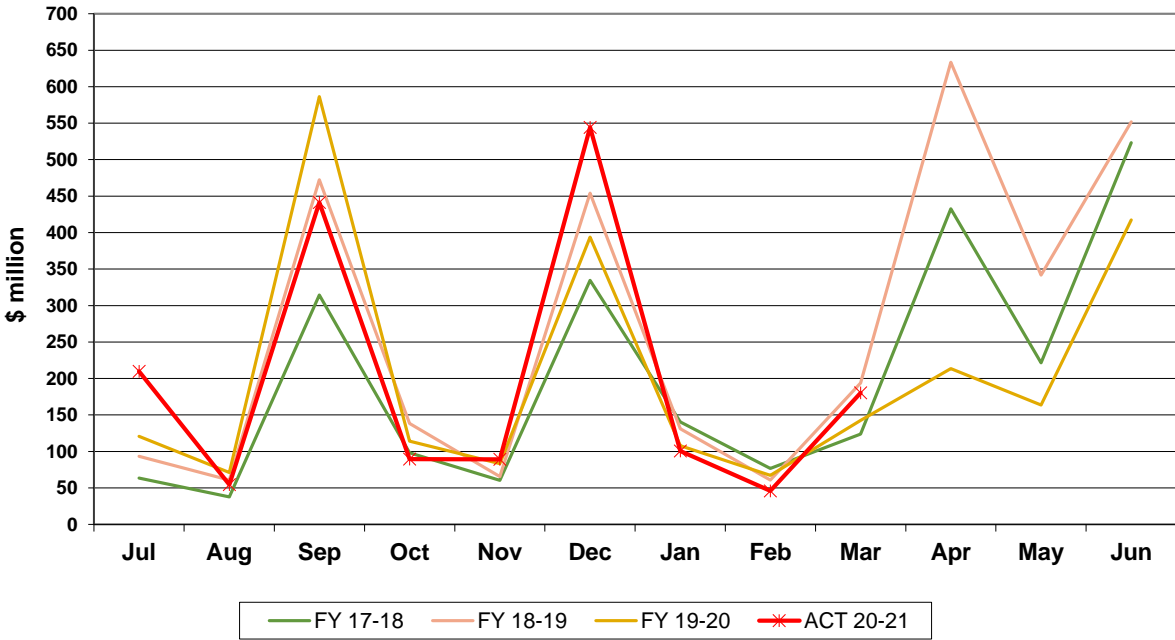


## HISTORICAL COMPARISON GRAPHS

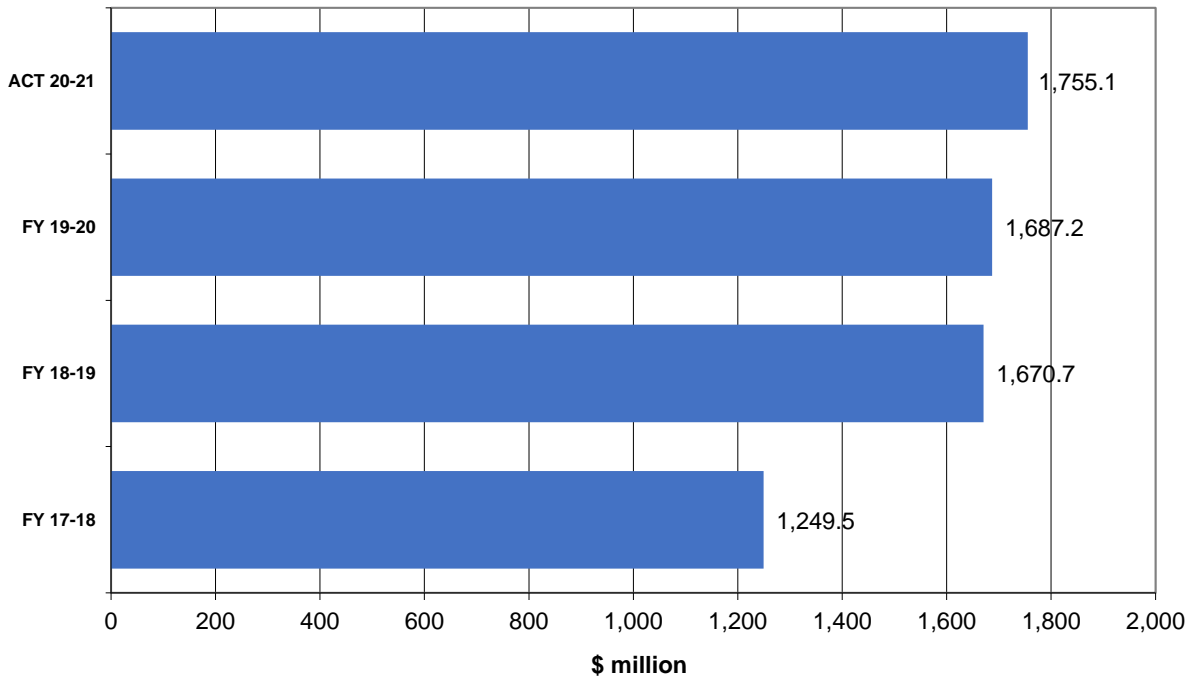

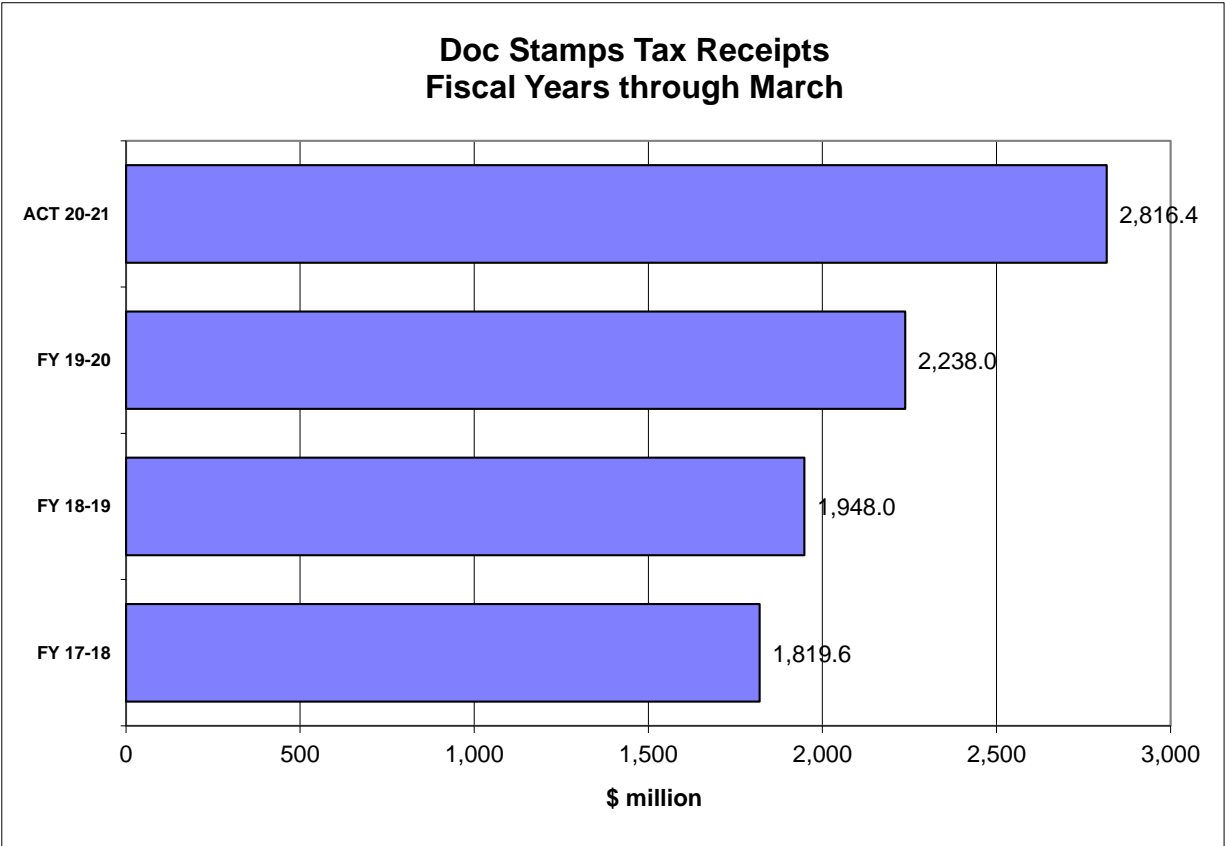
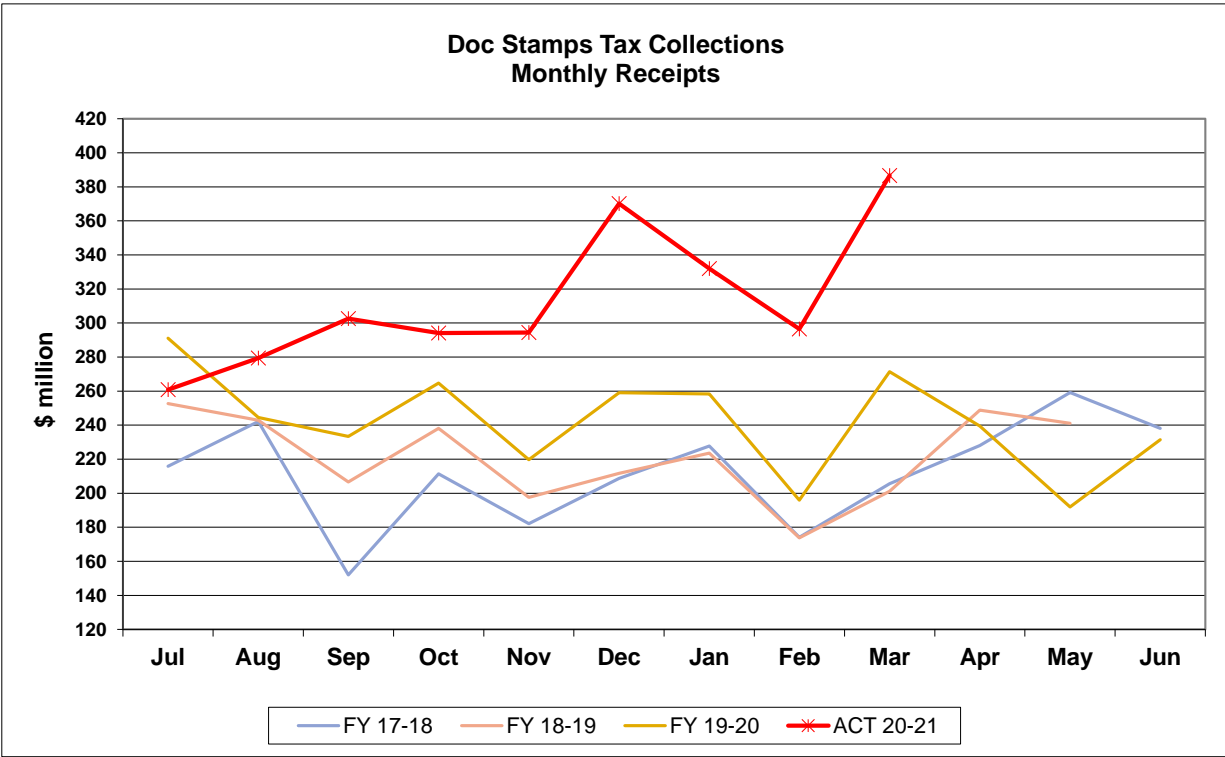


### Corporate Tax Collections Monthly Receipts



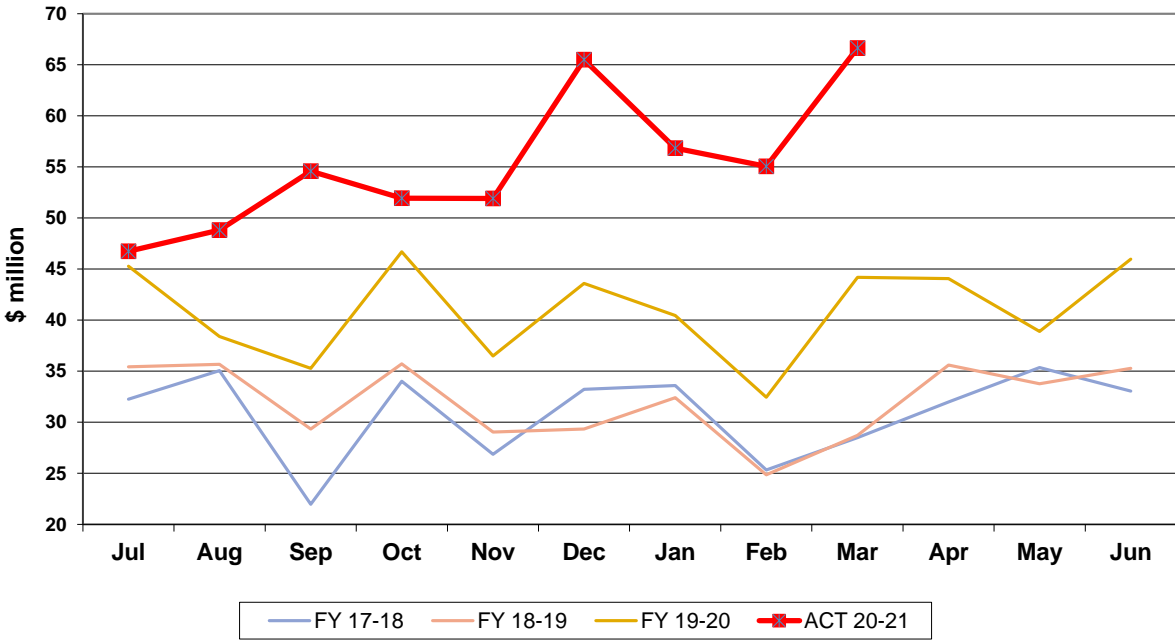
### Corporate Income Tax Receipts Fiscal Years through March



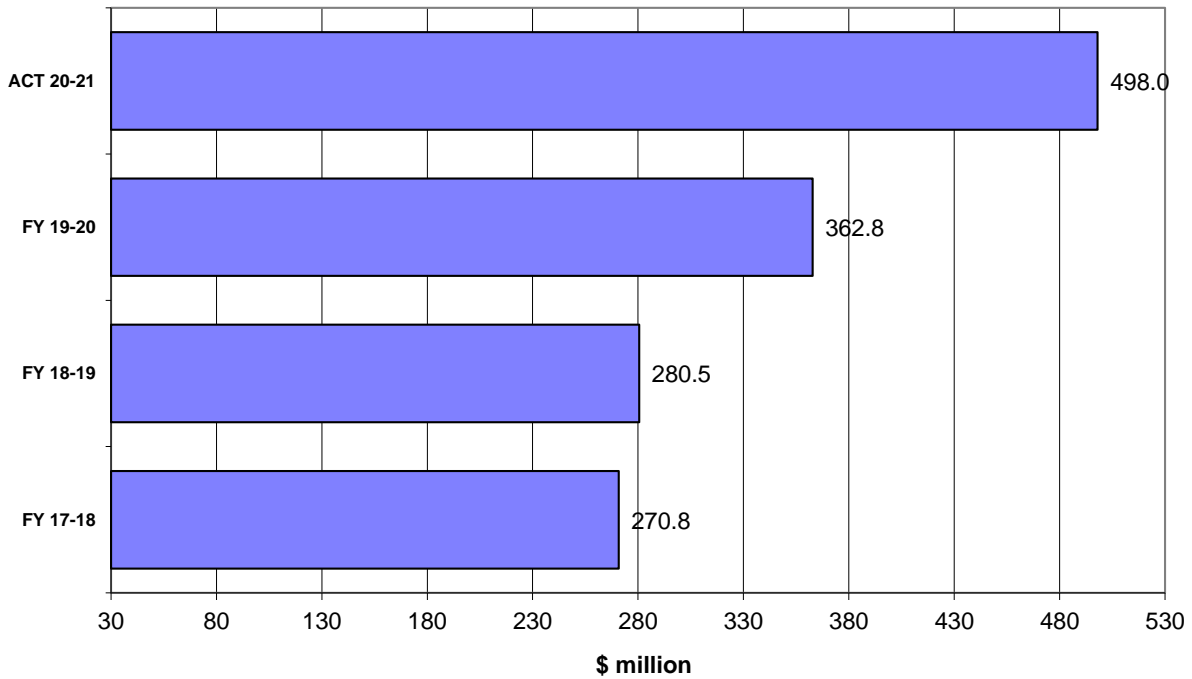




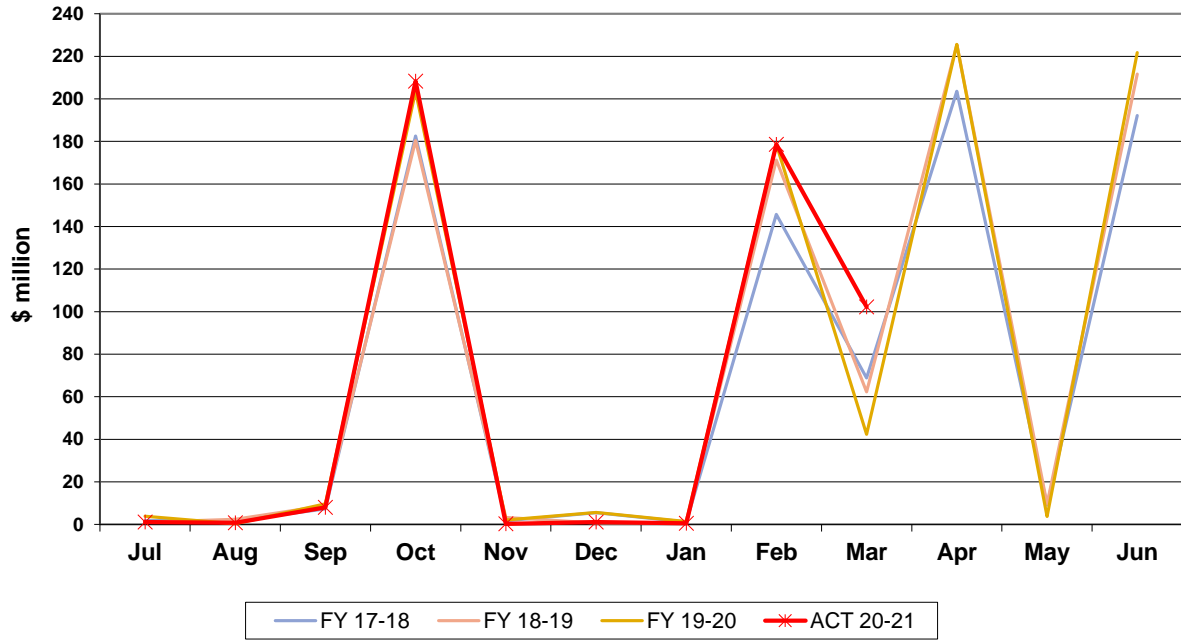
### Non-Recurring Intangible Tax Collections Monthly Receipts



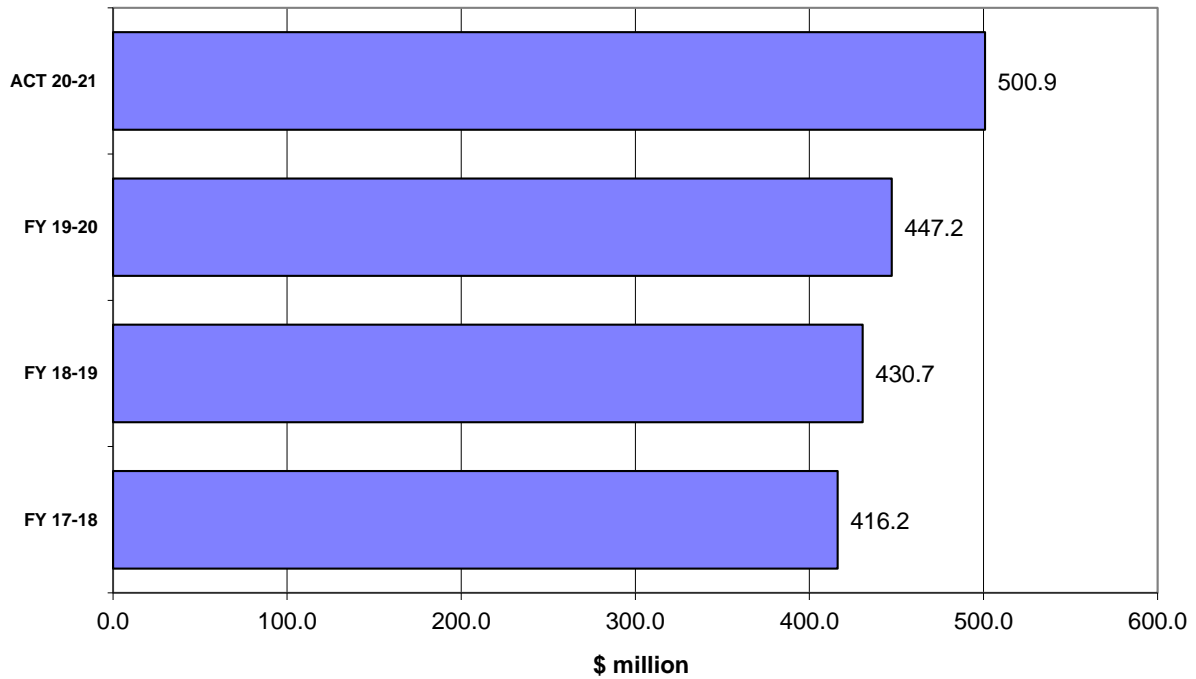
### Non-Recurring Intangible Tax Receipts Fiscal Years through March



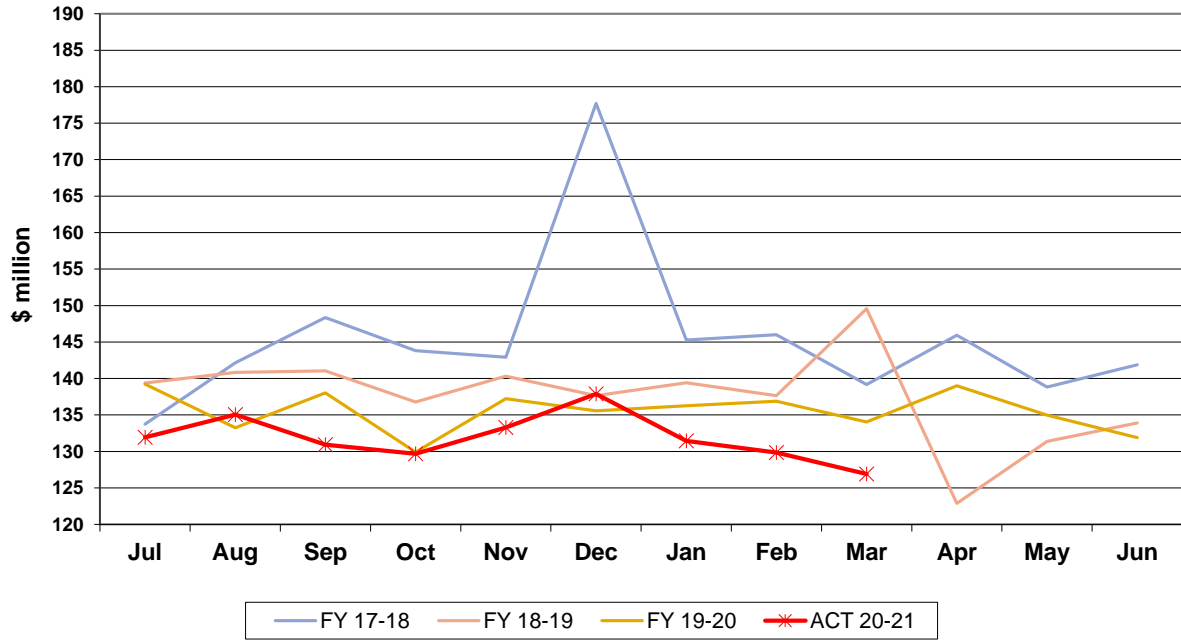
### Insurance Premium Tax Collections Monthly Receipts



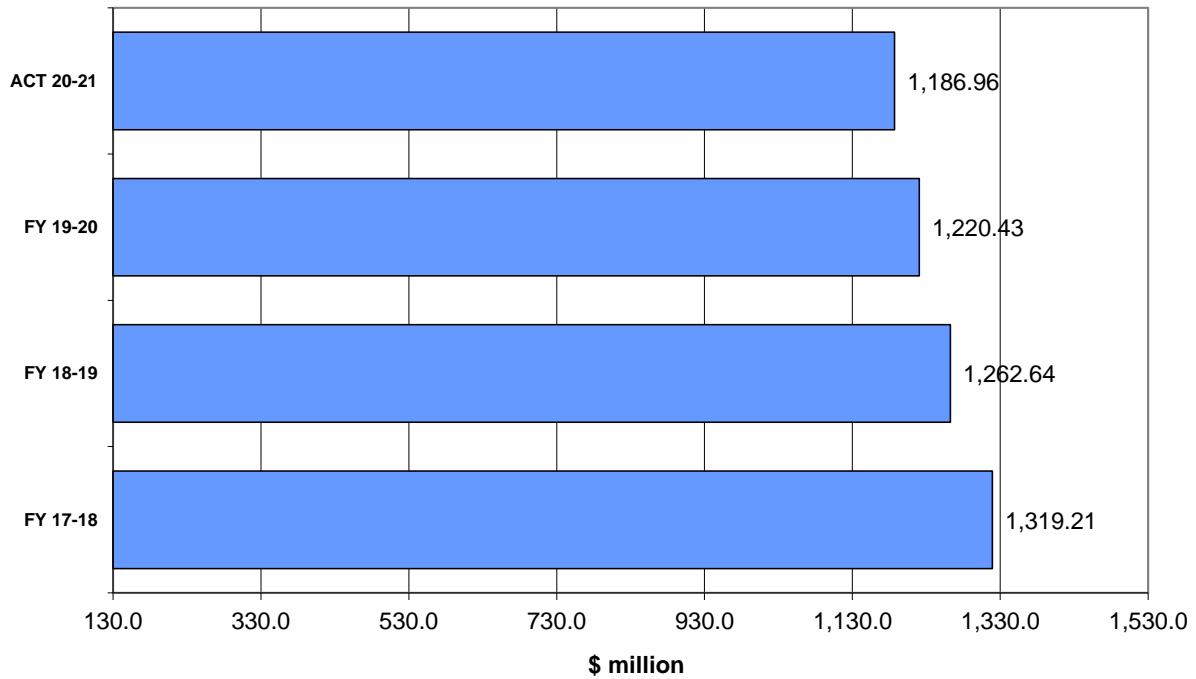
### Insurance Premium Tax Receipts Fiscal Years through March



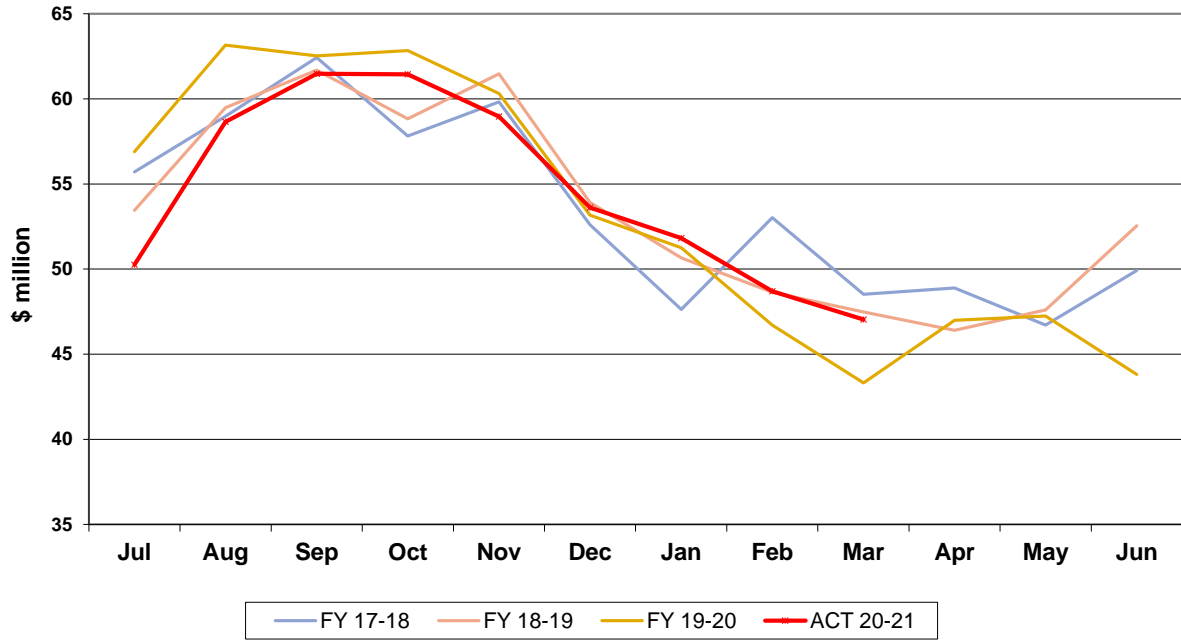

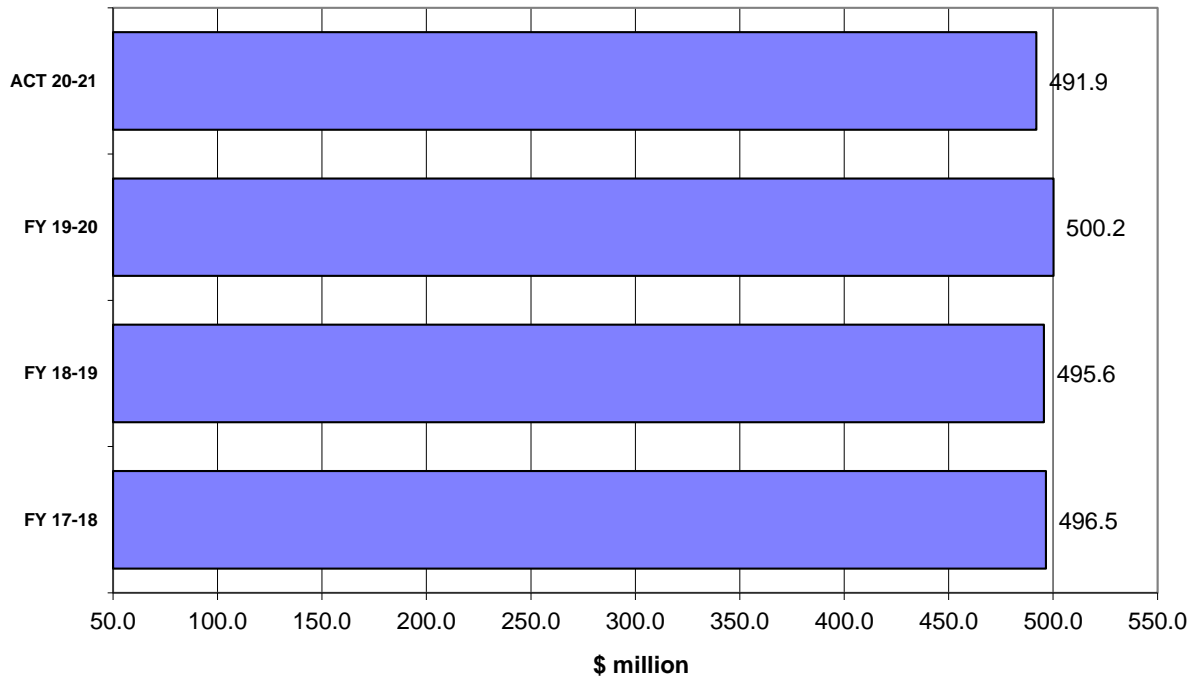

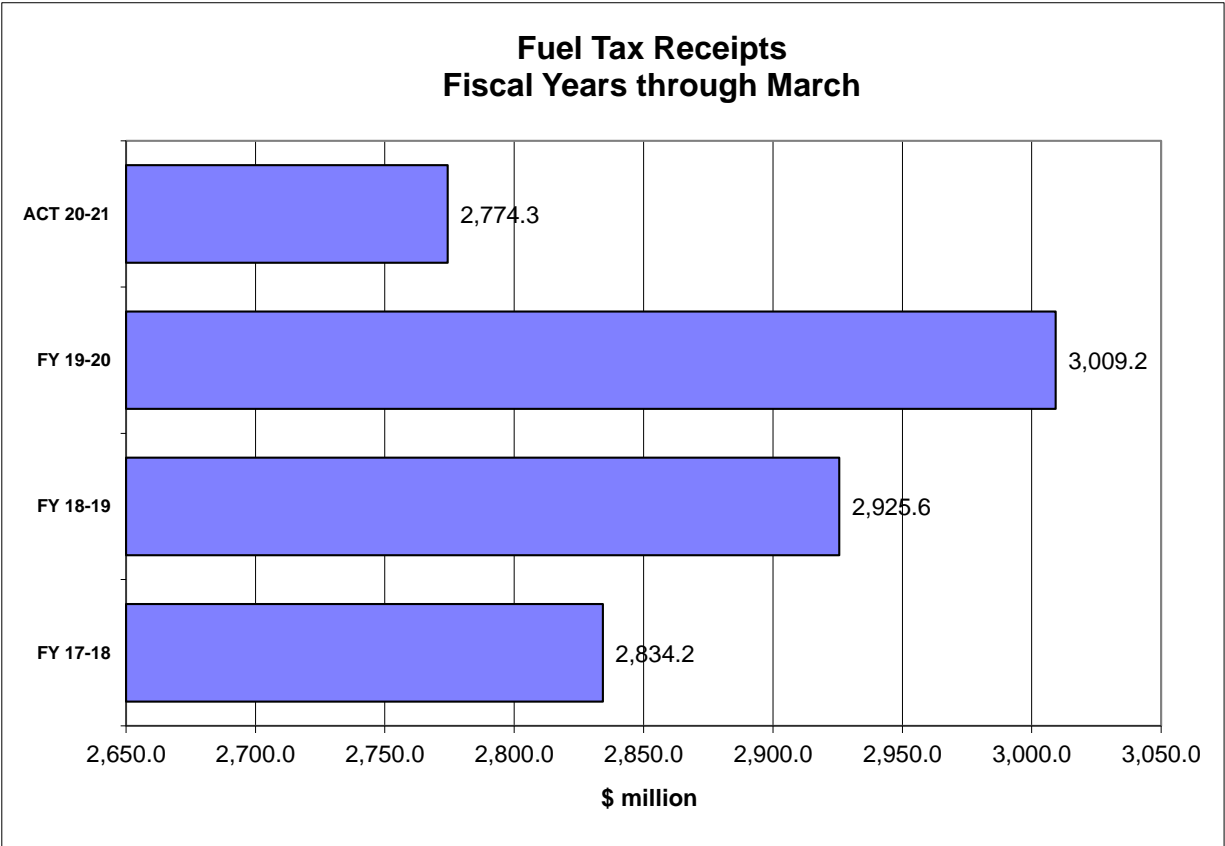
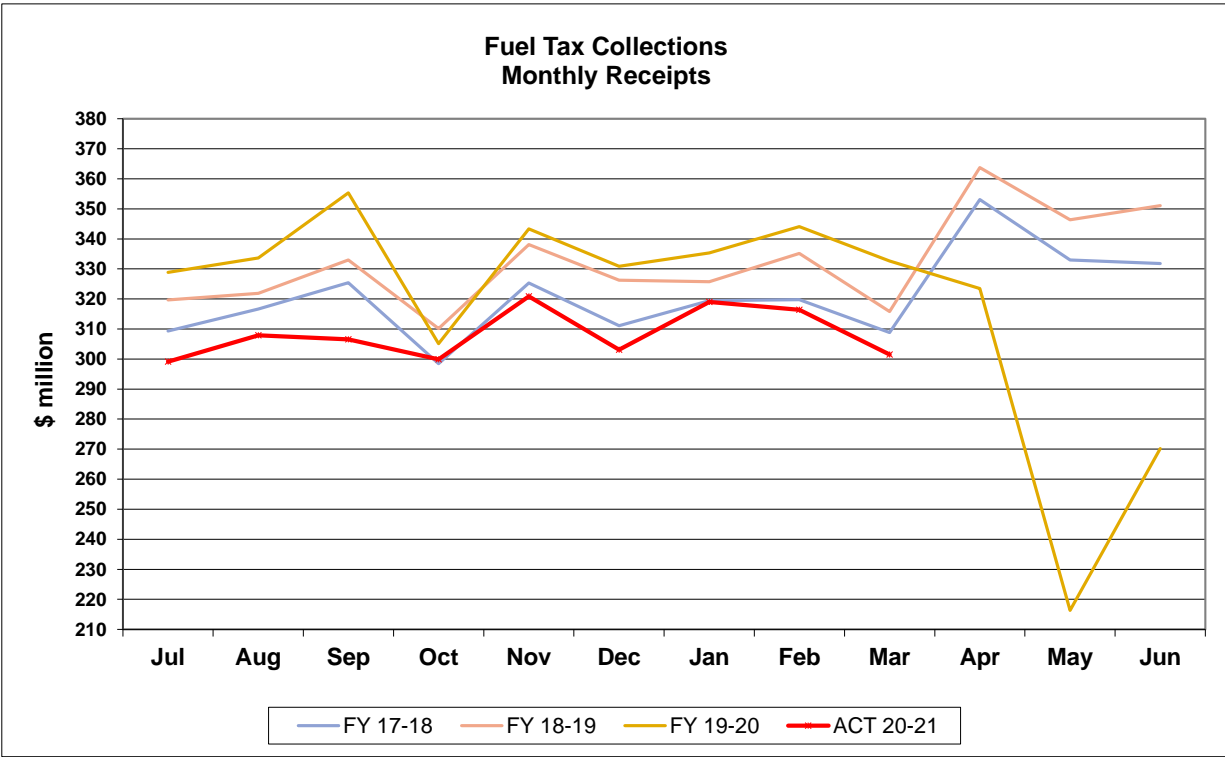


**2.5% Gross Receipts Tax Collections  
Monthly Receipts**

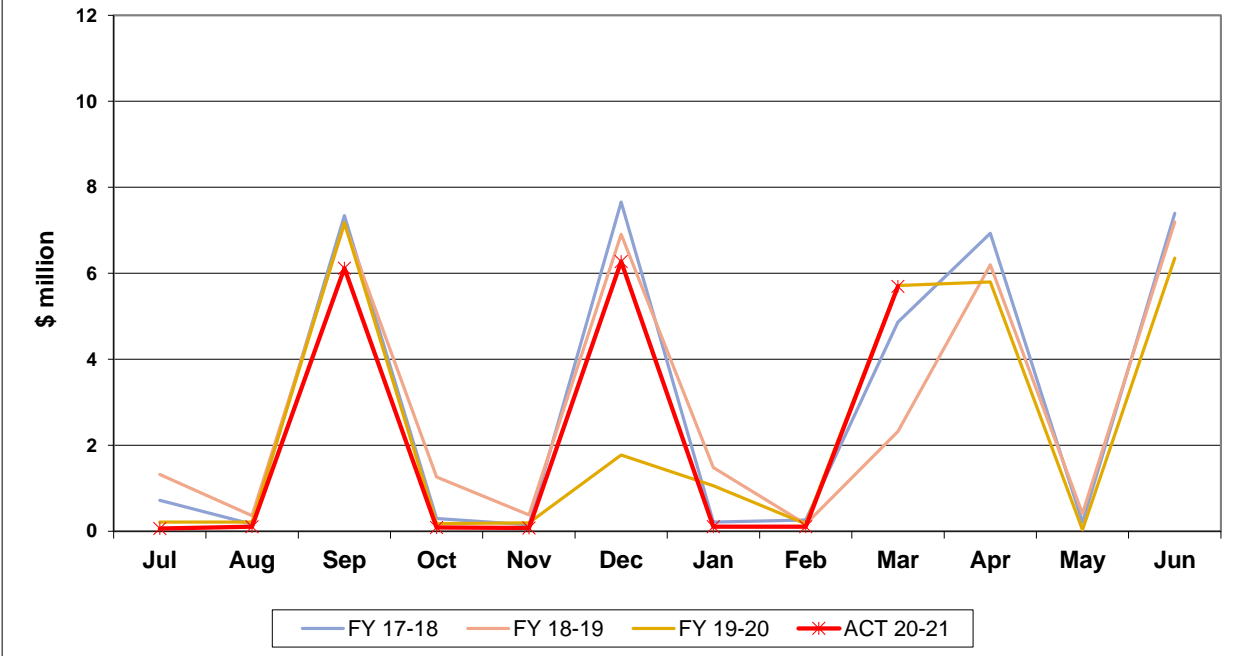


**2.5% Gross Receipts Tax Receipts
