Sales and Use Tax collections were above the estimate in November by \$30.1m (1.5%) and over the 2014 November collections by \$122.2m (6.2%). The estimates are based on the August 14, 2015 Revenue Estimating Conference (REC) (page 3).

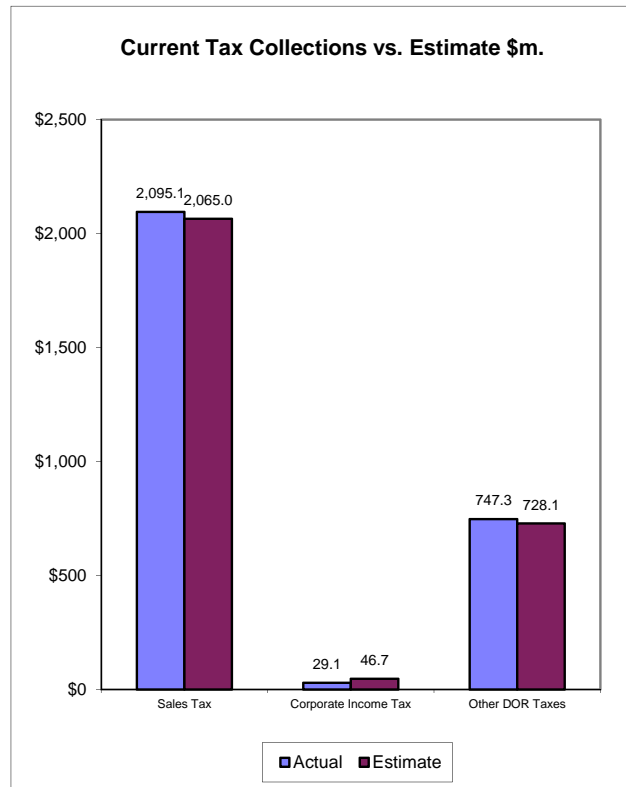
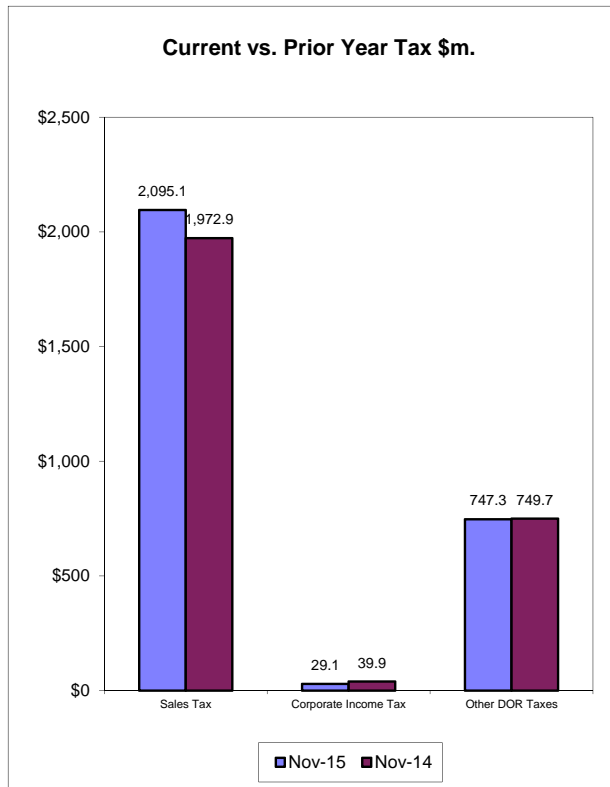
## CORPORATE INCOME TAX

CIT collections of \$29.1m in November were below the estimates by \$17.6m (37.6%) and below the 2014 November collections by \$10.8m (27.0%). The estimates are based on the August 14, 2015 REC conference (page 4).

## DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections were above the estimate by \$11.5m (7.1%) in November and above the 2014 November collections by \$18.0m (11.5%). The estimates are based on the August 14, 2015 REC conference (page 5).

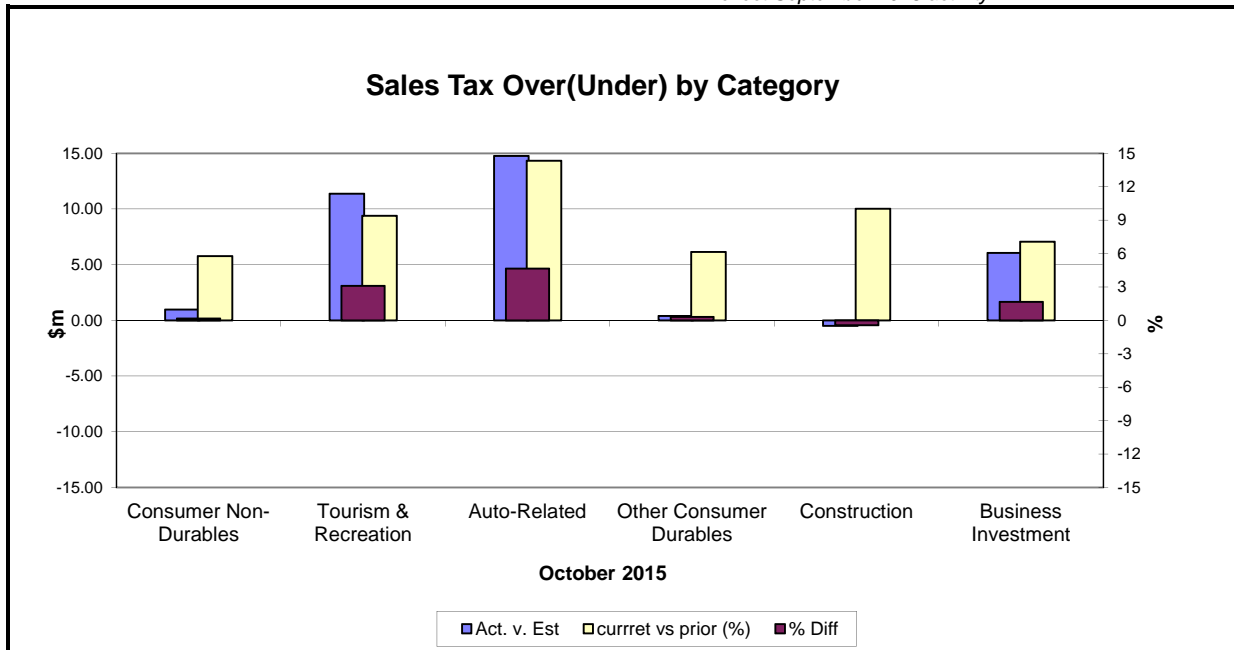
**SALES TAX ...**

... COLLECTIONS IN November 2015 of \$2,095.1m were \$30.1m (1.5%) above the estimates. The November Sales and Use Tax collections were \$122.2m (6.2%) above the November 2014 Sales and Use Tax collections (see Graph on page 1). The estimates are based on the August 14, 2015 REC conference.

**Analysis of October collections by category...**

All categories except Construction were above the estimates in October 2015, Auto-Related being the strongest (4.7%) followed by Tourism (3.1%) and Business Investment (1.7%). Construction category was below the estimates by \$0.5m (0.4%). Compared to October 2014, all six categories were above the same month collections last year, Auto-Related being the strongest (14.4%) followed by Construction (10.0%) and Tourism (9.4%).

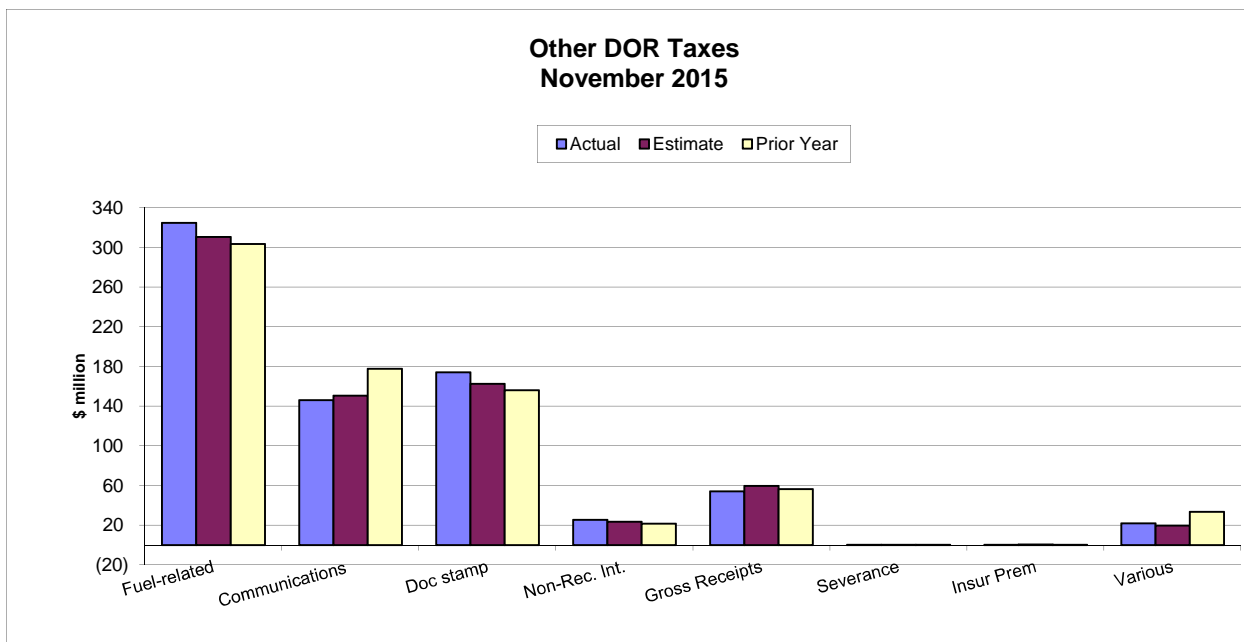
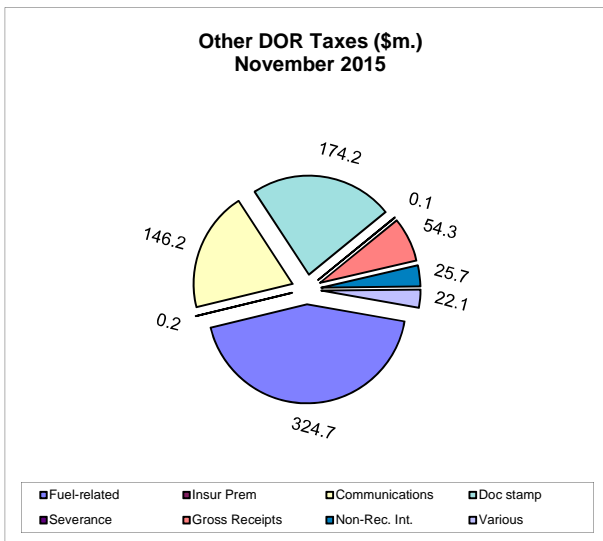
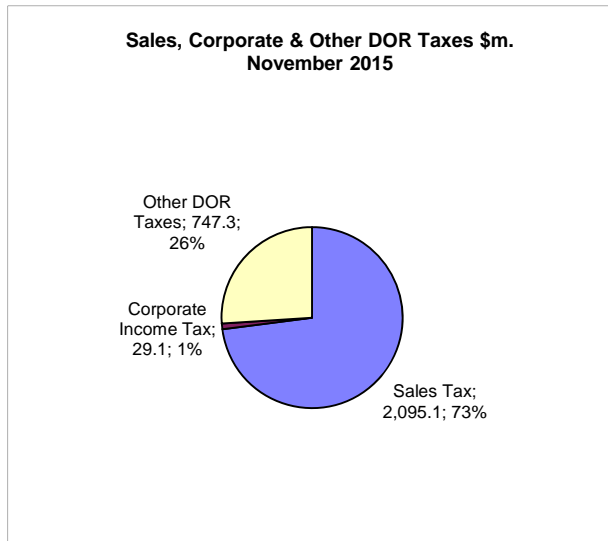
.... Collections of \$68.0m were \$17.6m (37.6%) below the November estimates. The November 2015 CIT collections were \$10.8 million (27.0%) below the November 2014 CIT collections. The estimates are based on the August 14, 2015 REC conference.



## OTHER DOR TAXES...

...excluding Sales Tax and Corporate Income Tax contributed \$747.3m to DOR tax collections in November 2015, which were \$19.2m (2.6%) above the estimates. The November collections were \$2.4m (0.3%) below the same month previous year's collections. Doc Stamps collections were \$19.2m (2.6%) above the estimates. The Doc Stamps collections in November were \$18.0m (11.5%) above the November 2014 collections. The non-recurring Intangible Tax in November was above the estimate by \$2.0m (8.3%). Compared to the November 2014's collections, the non-recurring Intangible Tax was 17.7% above.

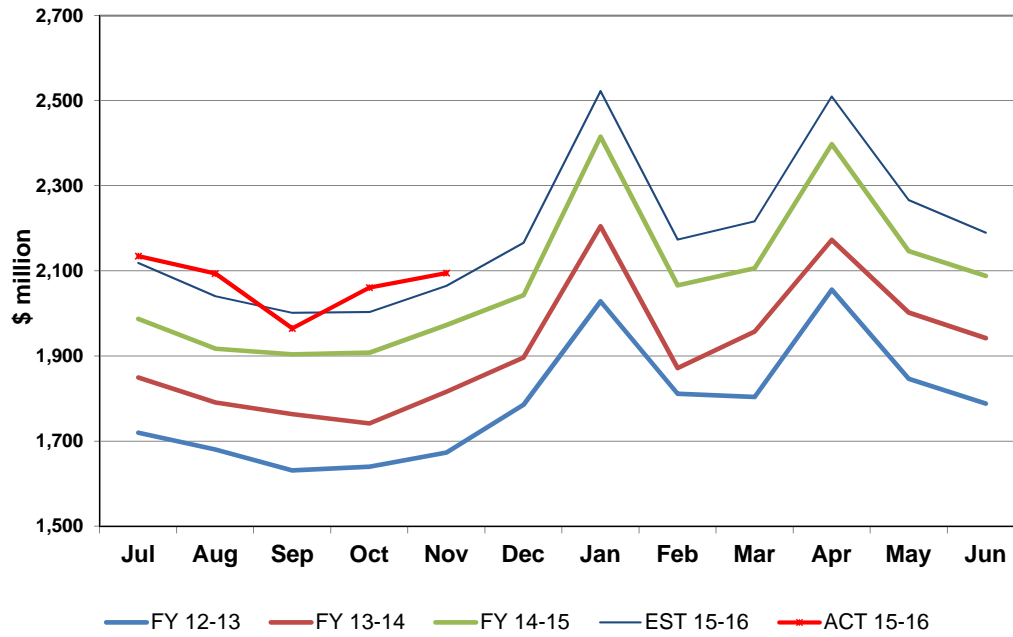
The November collections on Fuel Related Taxes were \$14.1m (4.6%) above the estimates. Compared to November 2014 collections on Fuel Related Taxes, the November 2015 collections were \$21.3m (7.0%) above. The Communications Services Tax collections were \$4.6m (3.0%) below the estimates. The 2.5% Gross Receipt Utility Tax collections in November 2015 were \$5.5m (9.2%) below the estimates, and were 3.9% below the same month's collection in the prior year. Insurance Premium Tax collections were \$0.5m below the estimates in November 2015.



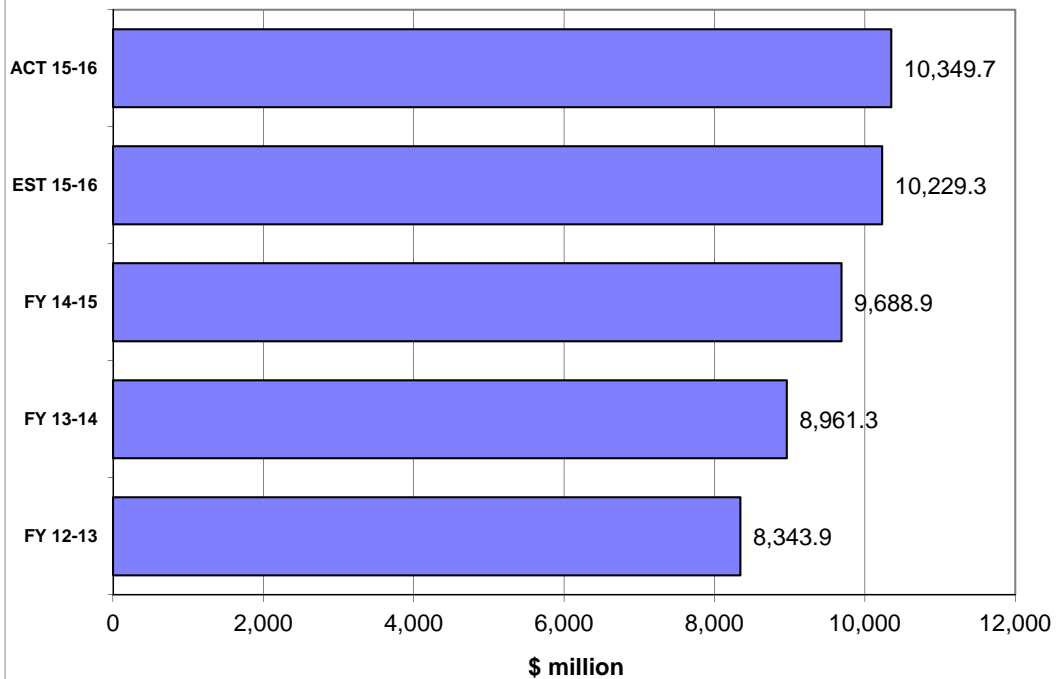
## HISTORICAL COMPARISON GRAPHS

*Pages 7-16 contain graphs for individual tax sources comparing the current fiscal year's actual and projected collections and collections for the three most recent fiscal years. The upper panel on each page presents monthly collections. The lower panel compares actual and expected collections on a fiscal year basis. In the lower panel, the bars prefaced by 'ACT' depict actual collections through the current month of each respective year. The bar prefaced by 'EST' shows that cumulation of the current year's DOR estimate through the current month. DOR's estimates are derived from estimates produced by the REC in **August 2015**. These estimates are adjusted to make them compatible with DOR's cash collection figures.*

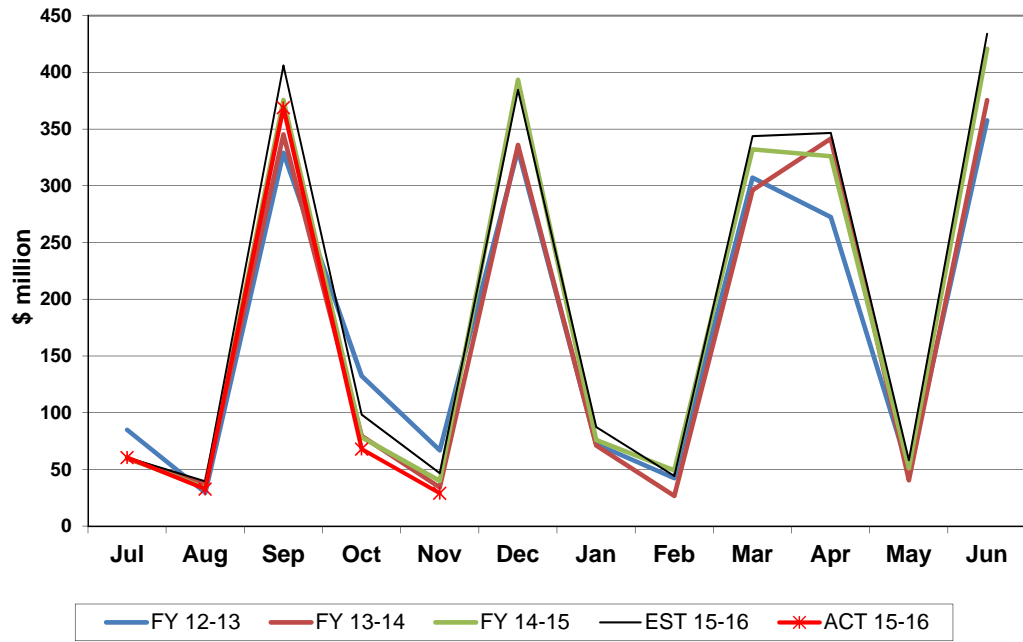
### Sales Tax Collections Monthly Receipts



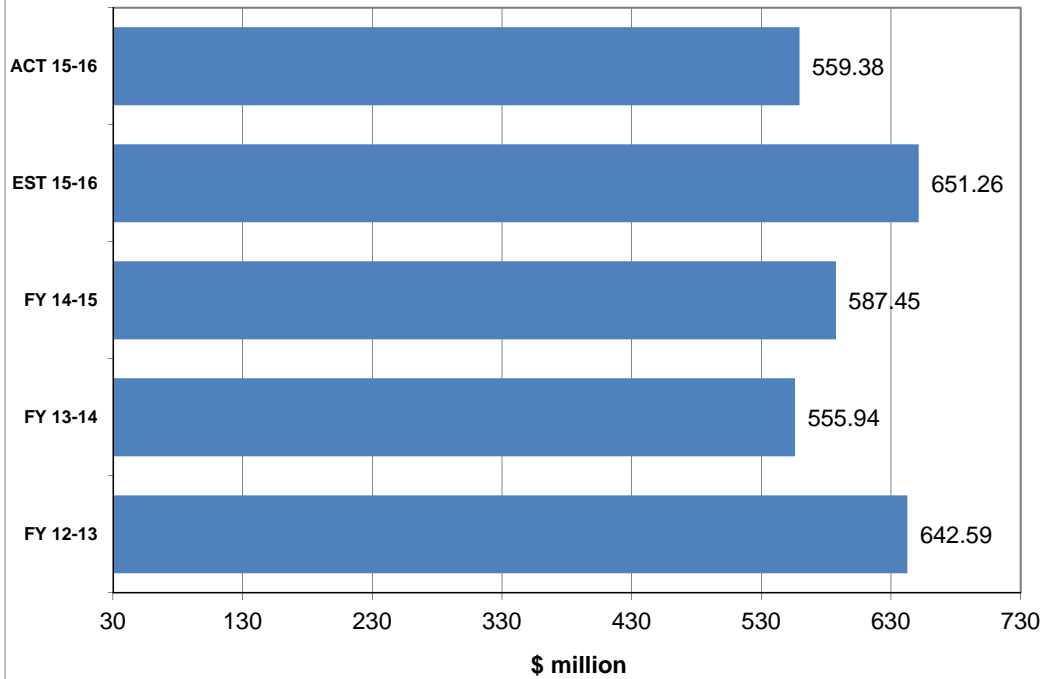
### Sales & Use Tax Receipts Fiscal Years through November



### Corporate Tax Collections Monthly Receipts

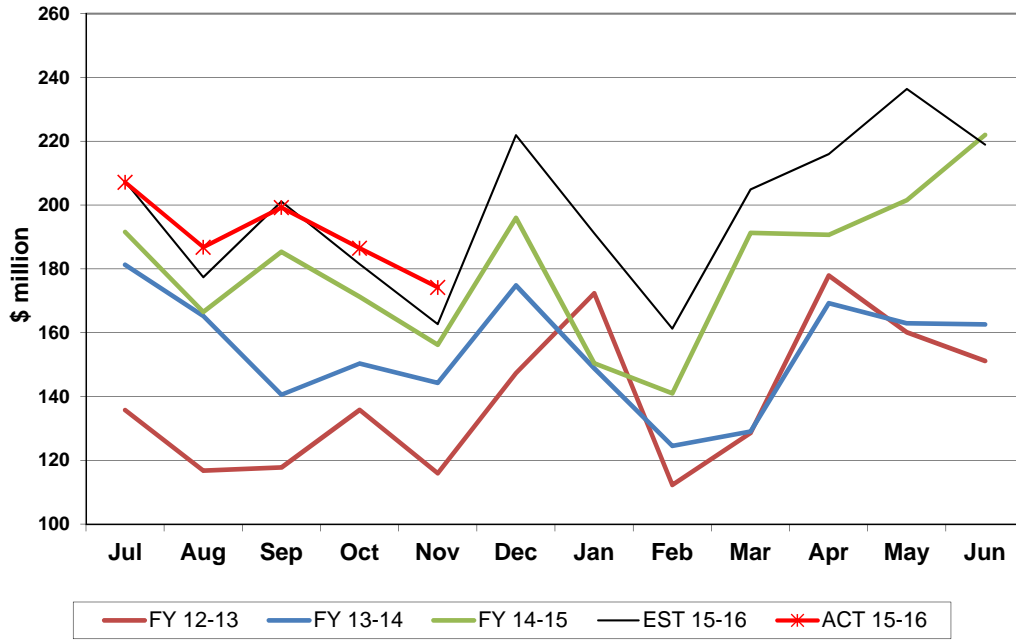


### Corporate Income Tax Receipts Fiscal Years through November

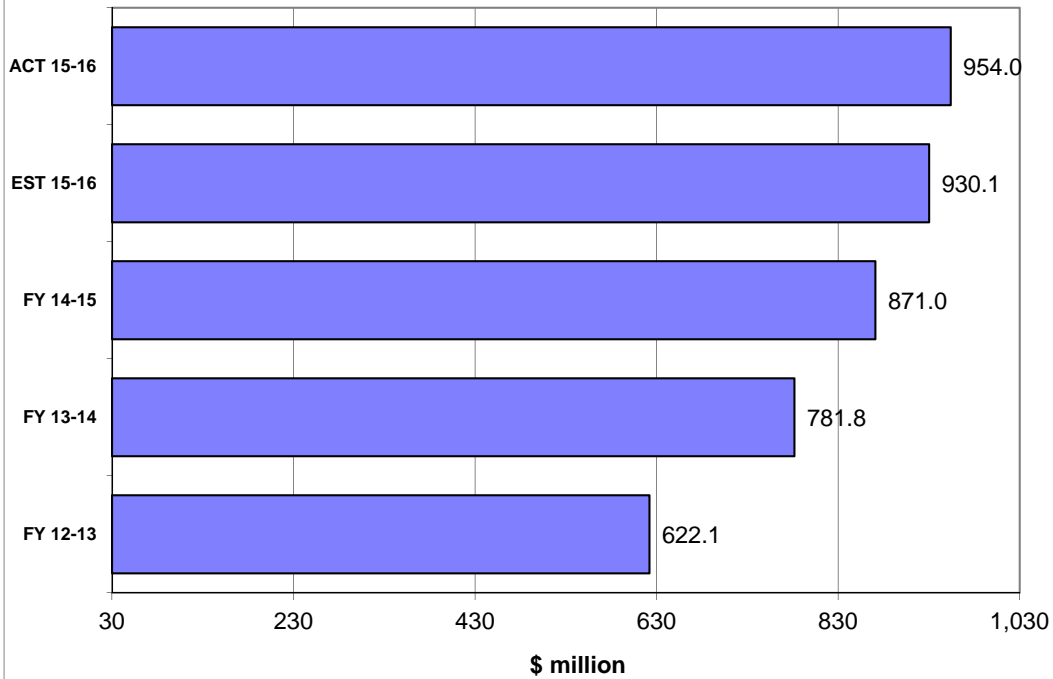




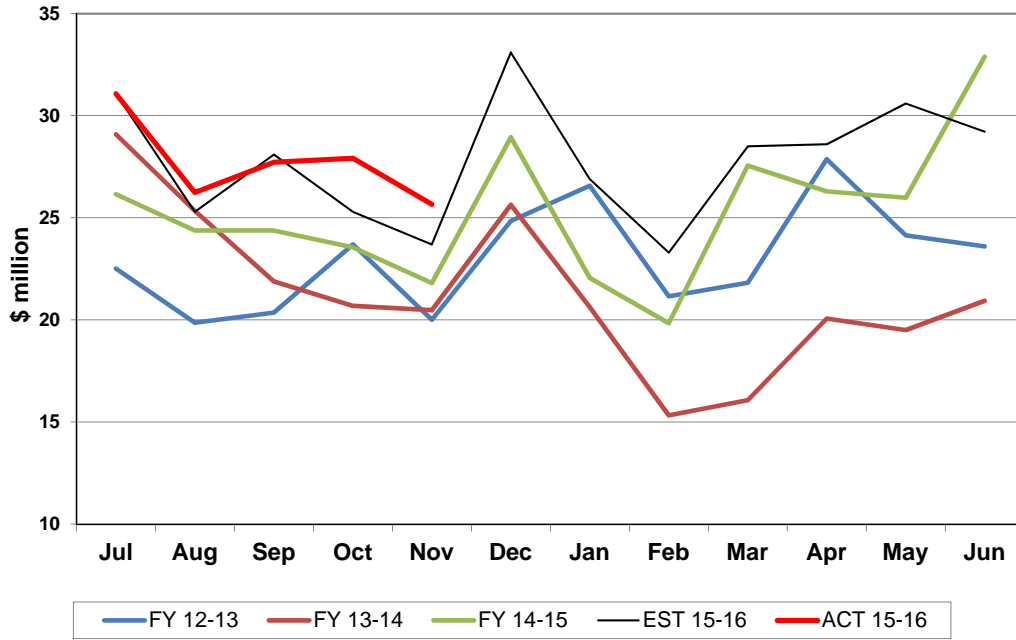
### Doc Stamps Tax Collections Monthly Receipts



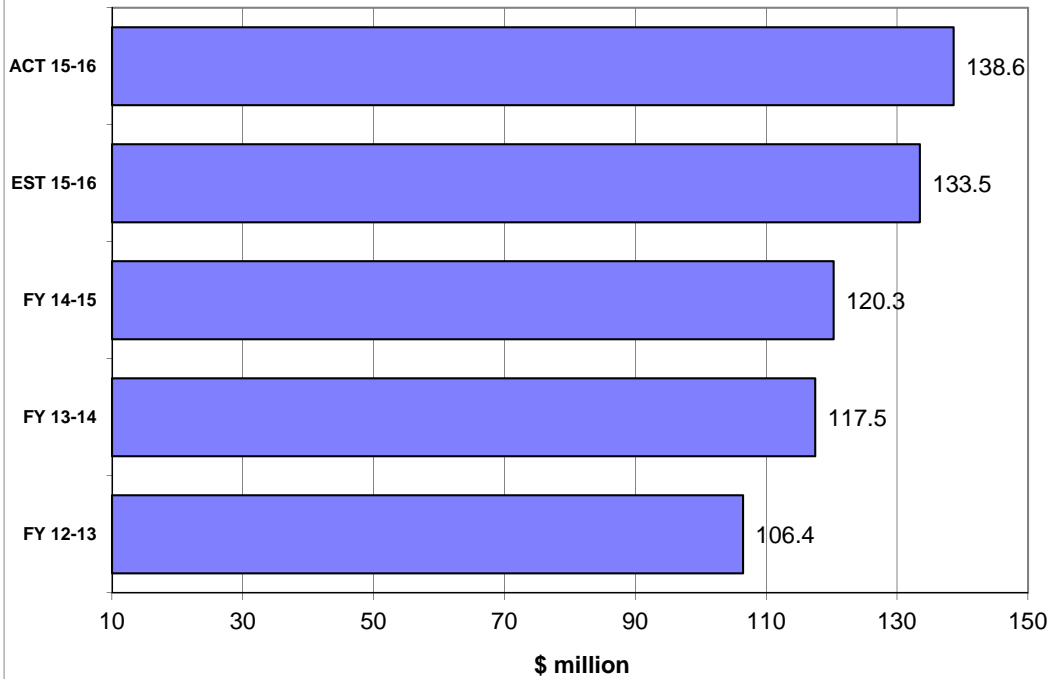
### Doc Stamps Tax Receipts Fiscal Years through November



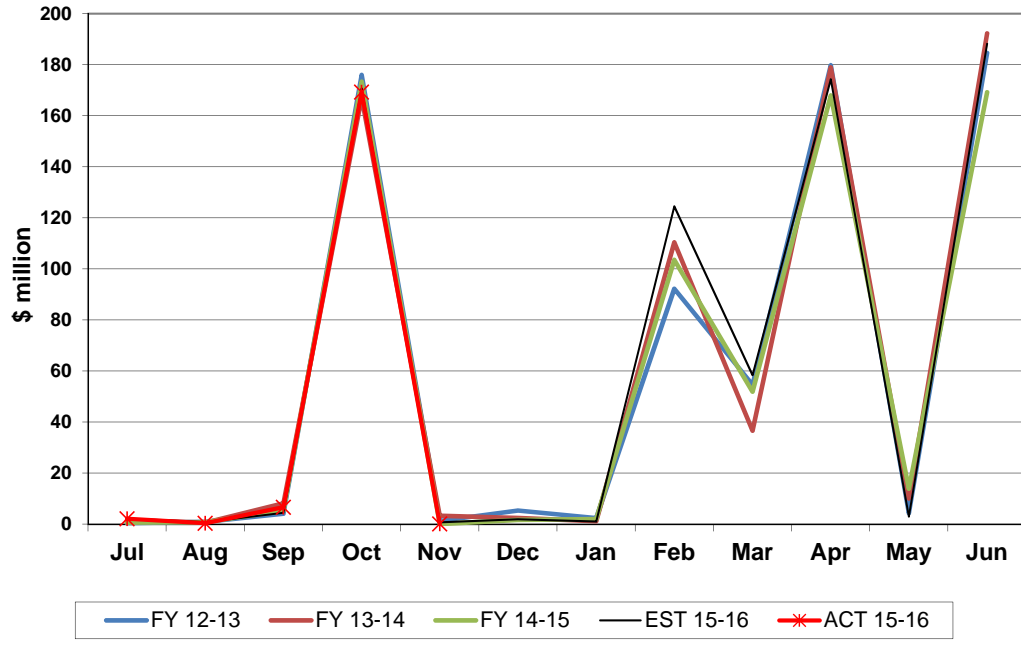
### Non-Recurring Intangible Tax Collections Monthly Receipts



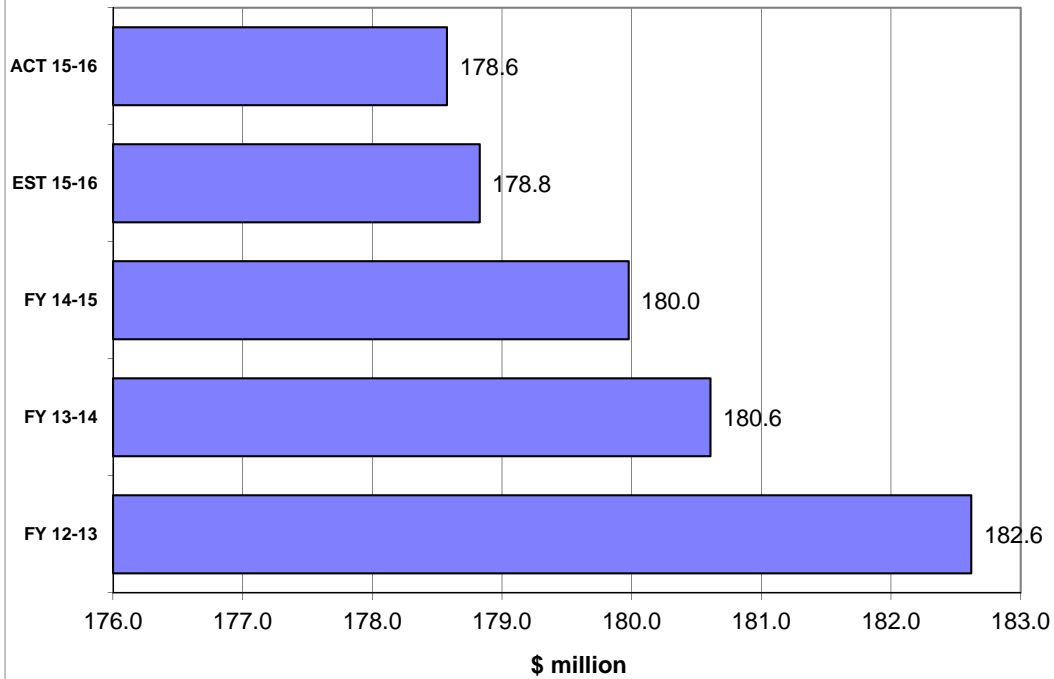
### Non-Recurring Intangible Tax Receipts Fiscal Years through November



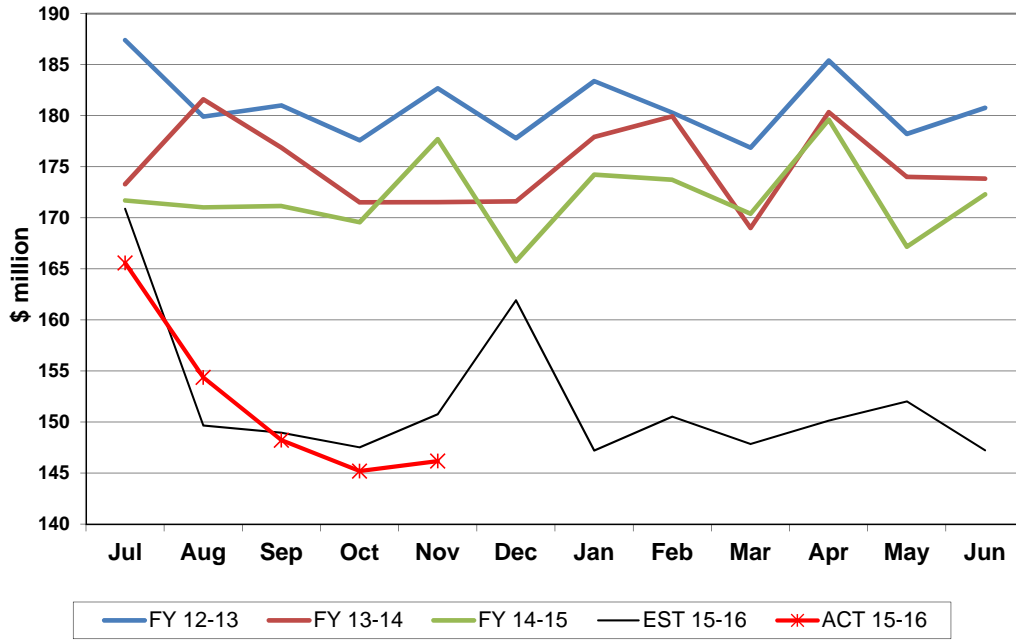
### Insurance Premium Tax Collections Monthly Receipts



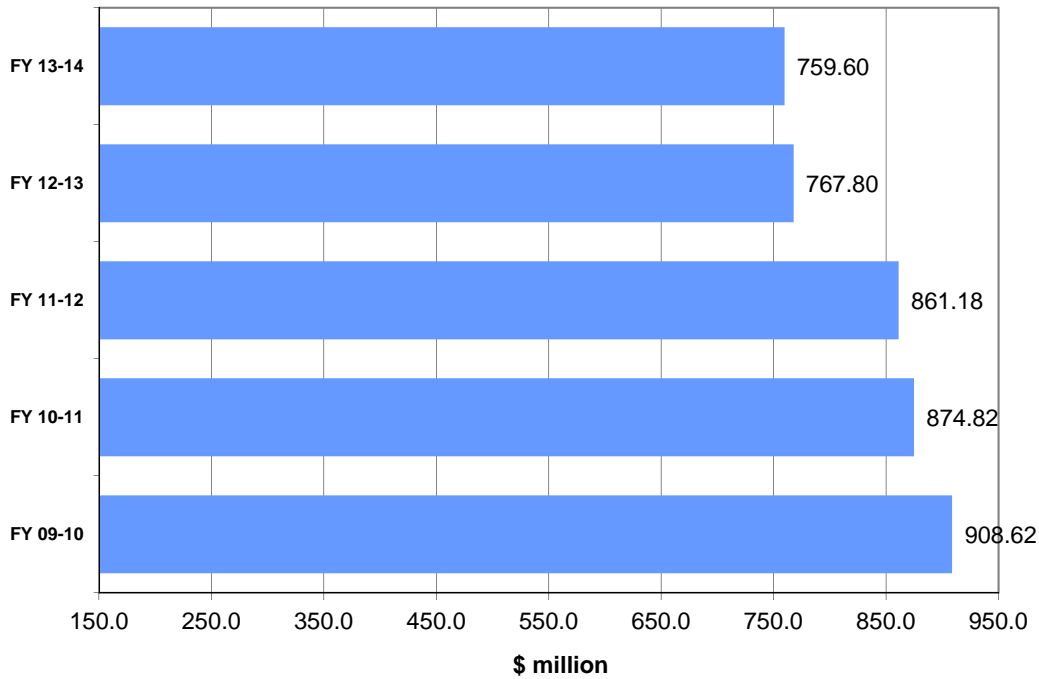
### Insurance Premium Tax Receipts Fiscal Years through November



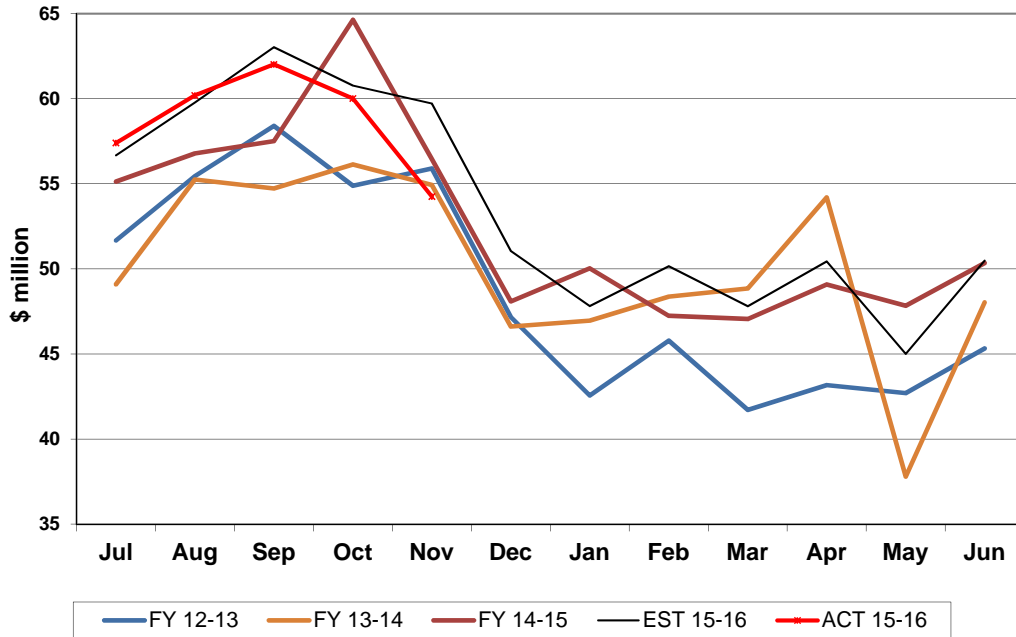
### Communication Services Tax Collections Monthly Receipts



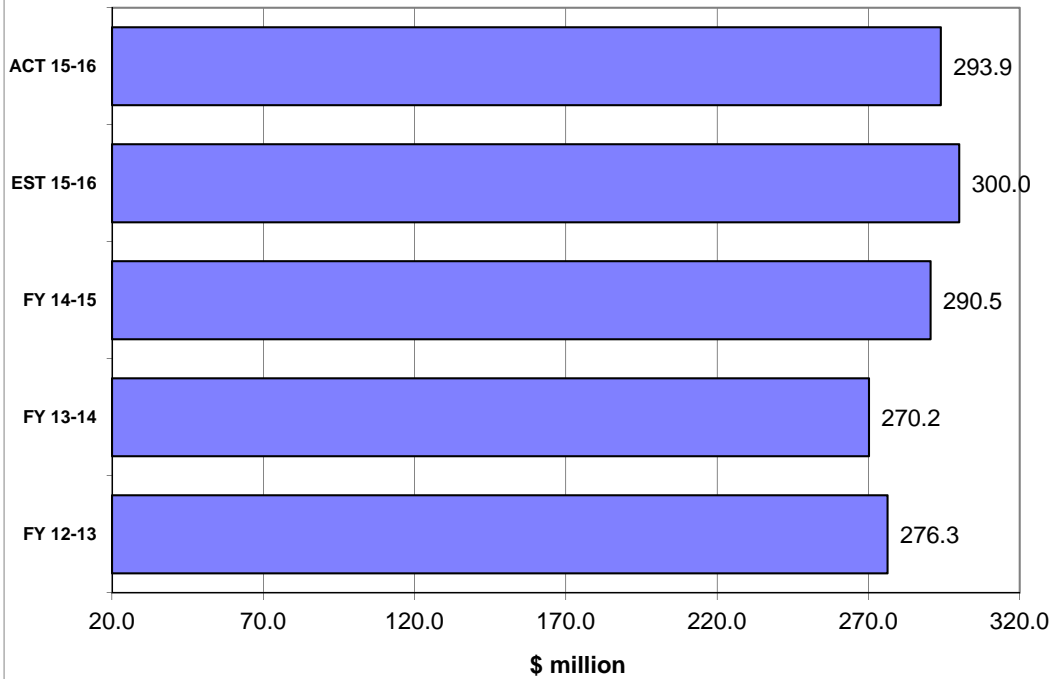

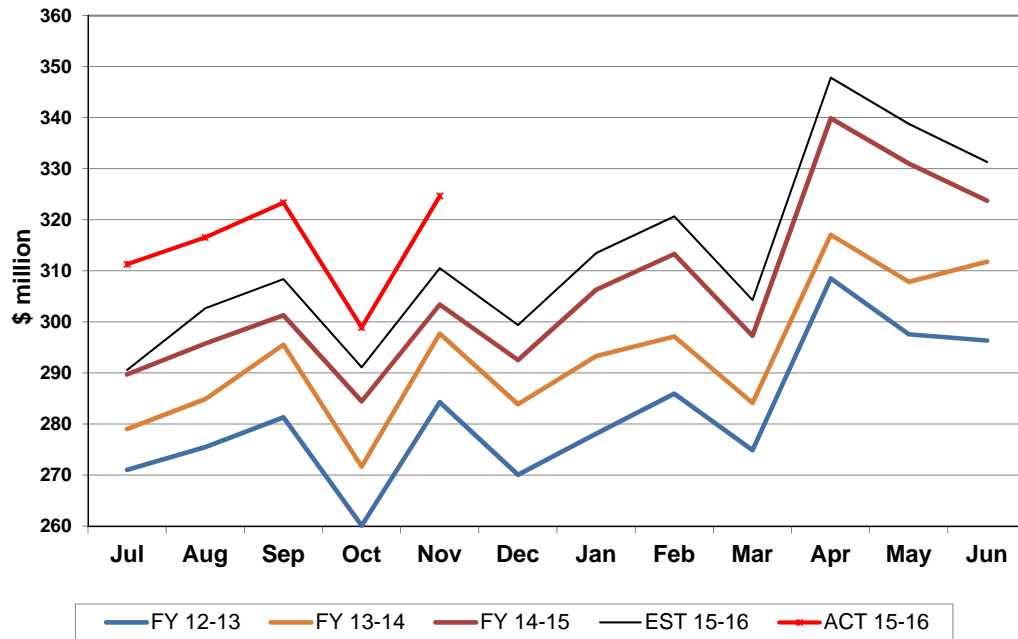
**2.5% Gross Receipts Tax Collections  
Monthly Receipts**



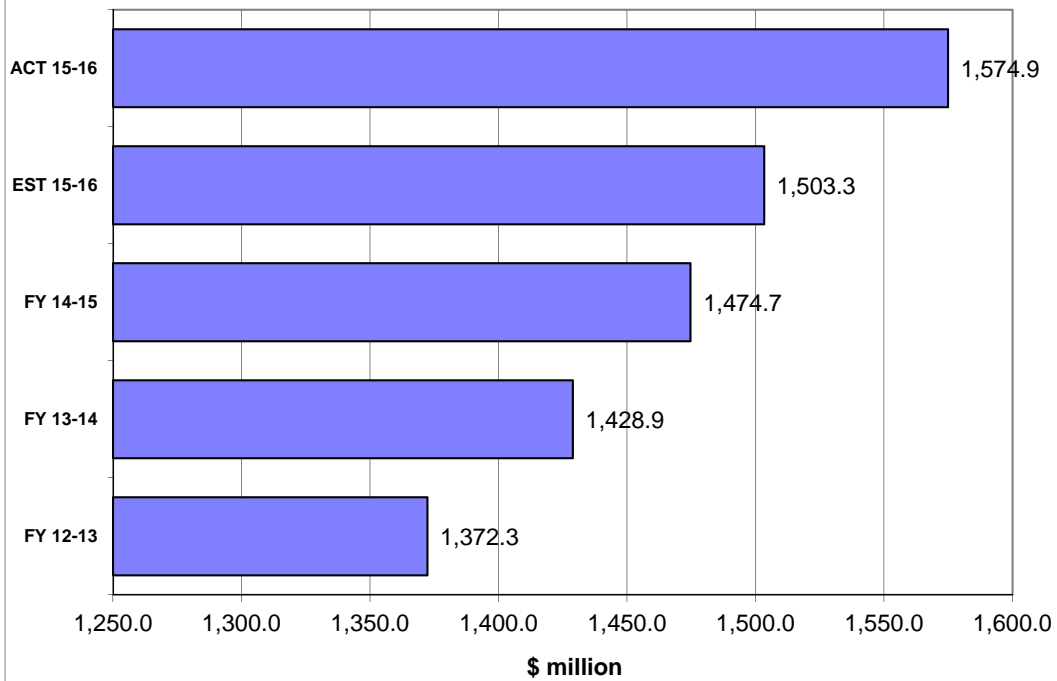

Fiscal Years through November**



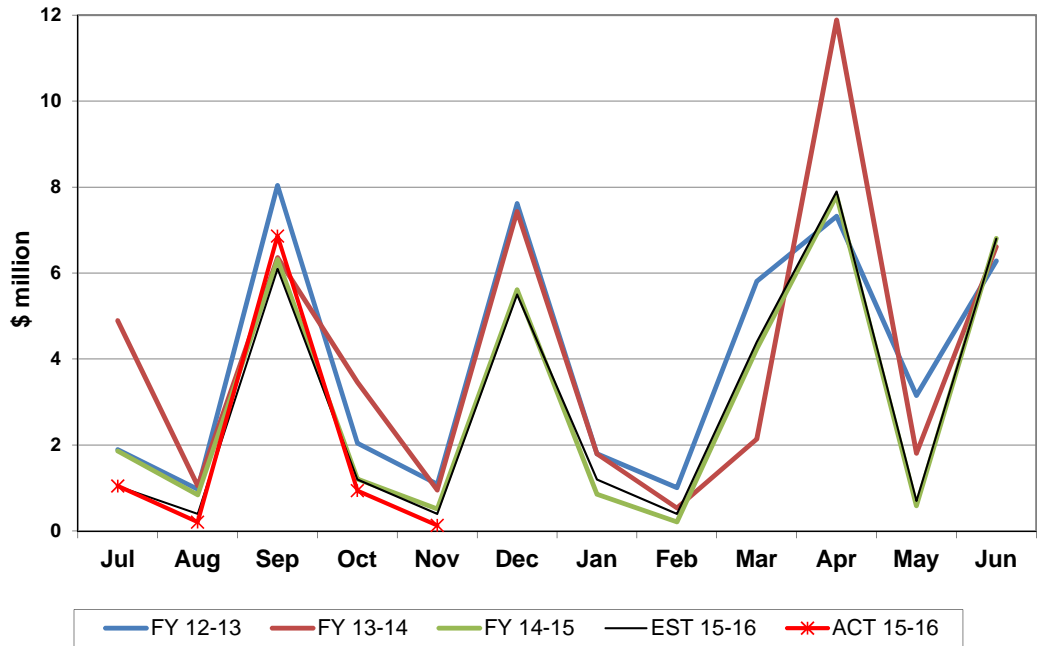
