Change in Local Communications Services Tax Rate Beginning May 1, 2022

Beginning May 1, 2022, the local communications services tax (CST) rate for the Town of Astatula will change.

May 2022 – Total Local CST Rate	
Town of Astatula (Lake County)	5.820%

The total local CST rate includes: (1) the local rate imposed under the CST statute; and (2) any county discretionary sales surtax imposed under the sales and use tax statute.

The local rate listed in the chart above is effective for all bills issued on or after May 1, 2022, regardless of the date the service is rendered or transacted. This rate will stay in effect until further notice by the Florida Department of Revenue (Department).
