Change in Local Communications Services Tax Rate Beginning January 1, 2024

Beginning January 1, 2024, the local communications services tax (CST) rate for Unincorporated Volusia County will change.

January 1, 2024 – Total Local CST Rate	
Unincorporated Volusia County	0.300%

The total local CST rate includes the local rate imposed under the CST statute plus any county discretionary sales surtax imposed under the sales and use tax statute.

The local rate listed in the chart above is effective for all bills issued on or after January 1, 2024, regardless of the date the service is rendered or transacted. This rate will stay in effect until further notice by the Florida Department of Revenue (Department).
