## **Holmes County Extends Indigent Care Surtax Expiration Date**

On November 5, 2024, voters in Holmes County approved a ballot referendum extending the expiration date of Holmes County's 0.5% indigent care surtax from December 31, 2026, to December 31, 2032. **The total state and local sales and use tax rate for Holmes County is 7.5%.** 

The total rate for Holmes County is composed of the 6% state sales and use tax rate, the 0.5% indigent care surtax rate, and a 1% small county surtax rate. State sales tax and local surtaxes collected must be reported and remitted to the Florida Department of Revenue (Department).

To calculate the total tax amount due, multiply the total amount of the sale or the taxable amount of each item by the total tax rate (state rate + surtax rate). The tax computation must be carried to the third decimal place and rounded up to the next whole cent when the third decimal place is greater than 4. The total tax due must be shown on each invoice.
