Sales Tax Exemption for Natural Gas Used to Generate Electricity in a Non-Combustion Fuel Cell Used in Stationary Equipment

Effective July 1, 2013, natural gas used to generate electricity in a non-combustion fuel cell used in stationary equipment is exempt from sales and use tax.

Sellers of natural gas are required to document exempt sales. Attached is a suggested certificate to be completed by the purchaser and maintained in the selling vendor's books and records.
