### **Firefighters' and Police Officers' Pension Trust Funds Excise Taxes on Insurance Premiums Chapters 175 and 185, Florida Statutes**

### **Updated Electronic Address/Jurisdiction Database for Determination of Insurance Premium Tax Situs**

Insurance companies use the Address/Jurisdiction Database to assign premiums to the proper local taxing jurisdictions for purposes of the Firefighters' and Police Officers' Pension Trust Funds. Companies may now access or download the updated [Address/Jurisdiction Database](#). The files contain changes that reflect annexations, new addresses, and other relevant changes submitted by the local jurisdictions. Insurance companies that would like to request a correction to the Address/Jurisdiction Database can do so by registering online at [floridarevenue.com/taxes/pointmatch](http://floridarevenue.com/taxes/pointmatch).

The Address/Jurisdiction Database is updated every April and October. Insurers should continue to report their local insurance premium taxes yearly on Schedules XII and XIII of their *Insurance Premium Taxes and Fees Return* (Form DR-908).

Insurers are encouraged to use the Address/Jurisdiction Database updated in October 2018 or April 2018 to report premiums for the 2018 calendar year (Form DR-908 due by March 1, 2019). However, insurers are held harmless if they use the Address/Jurisdiction Database updated in October 2017 to report premiums for the 2018 calendar year.

Online filing of Form DR-908, *Insurance Premium Taxes and Fees Return*, and Form DR-907, *Florida Insurance Premium Installment Payment*, is available. Taxpayers may log in to the [Florida Insurance Premium Tax Website](#) using their federal employer identification number (FEIN) and business partner number.
