



**Changes in Local Communications Services Tax Rates
Effective January 1, 2021**

Effective January 1, 2021, some local communications services tax (CST) rates will change. Total local CST rates include: (1) the local rate imposed under the CST statute; and (2) any discretionary sales surtax that may be imposed under the sales and use tax statute. The new rates below are effective for all bills issued on or after January 1, 2021, regardless of the date that the service is rendered or transacted. These rates will stay in effect until further notice by the Florida Department of Revenue (Department).

The following local CST rate changes are due to changes in the county discretionary sales surtax in which the jurisdiction is located.

Taxing Jurisdiction Removed

In the 2020 legislative session, House Bill 1215 (Chapter 2020-196, Laws of Florida) was approved abolishing the City of Weeki Wachee. Effective January 1, 2021, the City of Weeki Wachee will be removed as a local taxing jurisdiction for communications services. Customer service addresses located in and assigned to the City of Weeki Wachee should be changed to Unincorporated Hernando County for purposes of collecting, reporting, and remitting local communications services tax. The total local communications services tax rate for Unincorporated Hernando County is currently 2.140%. For more information, see **TIP 20A19-01**.
